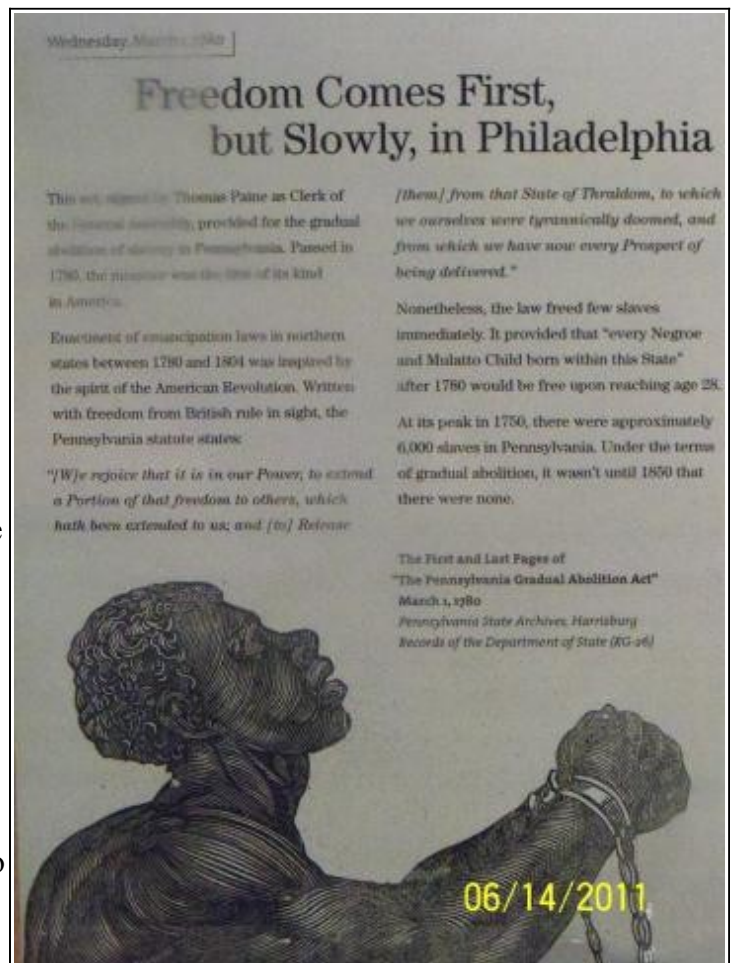
Worshipping the Beast

Black History *Month*? The manner in which American history is being taught today, one may think that every month of American history has been Black History Month. Wherever one looks, negroes are being foisted upon the public consciousness. Wherever one looks, imagined negro achievements are exalted and trumpeted while actual and tangible White accomplishments and White history are being diminished and ridiculed, and even criminalized.

For instance, walking through the National Constitution Center in Philadelphia, there is nothing at all of any real substance on display about the American Constitution itself. And you certainly will not find the actual *text* of the Constitution. Rather, there is talk about negro slavery, freedom, and civil rights at every turn. The only other topic treated at length is woman's suffrage, wherever the Center has exhibitions for the period following the Civil War. The entire purpose of the National Constitution Center seems to be the exaltation of negroes in American society, and secondarily the exaltation of women, all while White culture is denigrated and White men are marked off as hypocrites. Absolutely forgotten is the inconvenient truth, that the American Constitution was a document created by and for White men, and for those White people whom the men that created it were representing. Explicitly stated in its preamble is the declaration that it was written to "secure the Blessings of Liberty to ourselves and our Posterity", which means the *descendants* of those very same White people. It was never the plan of the founders of this nation to include anyone but Whites in its polity. Negroes were never intended to be considered as equals, as citizens, or as the recipients of this great White heritage. In taking them into the fold, so to speak,

Whites have spit in the face of their ancestors, who actually had cared about them as their posterity that they left them a document whereby they could preserve their freedom and their independence - if only they'd have actually *read* that document.

The so-called American Civil War was not even about slavery, although one may convince few people in the general public of that fact today. Slavery was only a minor issue at the start of the war, which was really about States' rights and the sovereignty of the individual states. The Union was formed for the benefit of the States, and not the States for the Union. But the National Constitution

Center also denies the plausibility of the sovereignty of the individual States, therefore denying the basis upon which the federation was originally built. That basis - the sovereignty of the separate States - was something even the Federalist and former President [John Quincy Adams fully acknowledged in 1839](#). Therefore even the very premises of the Center as it presents the Constitution are founded upon lies.

The negroes were only used as a wedge by Abraham Lincoln to cause division in the South when he issued his so-called *Emancipation Proclamation* in 1863, over 24 months *after* the secession of the southern States. Mary Boykin Chesnut, the wife of a Confederate general from South Carolina, wrote in her memoir *A Diary from Dixie* on p. 67 that “Yesterday some of the negro men on the plantation were found with pistols. I have never before seen aught about any negro to show that they knew we had a war on hand in which they have any interest.” This section of her diary is from May 25th through June 24th, 1861, over 18 months before Lincoln's so-called *Emancipation Proclamation* was issued. During the war itself, negroes being used as a wedge against southern Whites, slavery and the prospects of freedom for negroes only then became an issue. Convenient for the Jewish intent to elevate the status of the negro in White society after the war, the true causes of the secession, and the fact that the war was truly an act of northern aggression, have been purposely forgotten.

In a true civil war, competing interests fight for control of the same government. In the American so-called “Civil War”, the South, which wanted its own government, was conquered by the North and forced to do its will. That is not a civil war: it is a conquest. The people who produce history books and text books today have largely overlooked that. Such is the propaganda of imperialism, and many more things have also been forgotten in its wake.

In the years prior to the Civil War (better labeled the *War of Northern Aggression*), the debates over whether newly inducted U.S. States would allow slavery or not had little to do with empathy for negroes. Certainly there were *some* wealthy upper-class, elitist Whites - much like the liberals of today - who had such misguided empathy, they themselves not actually being acquainted with negroes on a social level - however these were few. Alexander Hamilton was early and prominent among them, but even Aaron Burr evidently agreed with him in that one area. Rather, those debates had much more to do with jobs for working-class White men, and the working-class White men of the 19th century had no empathy for negroes: they instead saw them as loathsome economic competitors. Working-class Whites knew that they could indeed compete with and prevail over negroes for jobs when all else was equal, but they could not compete for jobs with negroes who were slaves and still expect to earn a decent wage for their own labor.

Working class White men, who were of course by far the majority of the White population, therefore had an enmity for the institution of slavery that was totally independent from any thought for the supposed plight of the negro. Just like the illegal immigration issue of today, where the power-brokers who control capital and industry can exploit cheap labor and put free White men out of work, Whites were concerned with a loss of economic opportunity in any state where cheaper black slave-labor was imported in quantity. The capital barons of the North, where they in turn could not control the southern slave labor market, and where they also could not promote the use of slave labor as it was quite unpopular in the more densely populated North, took advantage of the division over slavery and sought to destroy it, freeing negroes so that they could then bring them north and exploit both them and the White working class. The involvement of English bankers in Southern affairs and the competition for the raw materials of the South only exacerbated the situation. The slavery issue had everything to do with the advent of Jewish capitalism in Christian society, and its incessant thirst for cheap labor so that it could pile up profits for itself. It had nothing to do with any sincere care for the plight of the negro. The negro fared much better under slavery than he has in any of the urban ghettos that he has occupied since. Just like the socialist revolutions designed to destroy the middle and upper classes of 19th century Europe, the American "Civil War" was just another chapter of the war being waged by the dragon, the capitalist Jew, against White Christian society everywhere. The Civil War did not free the negro: it enslaved us all under carpetbagger capitalism. Its impact continues with us to this very day.

But even with the freeing of the negro, and the artificial creation of negroes and other aliens as "citizens" through the unlawful 14th amendment (unlawful because it is contrary to the very intent of the Constitution), the Jew could not destroy the basic fibers of Christian society, since without intervention Whites and negroes generally and naturally tend to self-segregate. Neither were the advent of Bolshevism and the two World Wars - all inspired by or instigated by Jews - enough to do so by themselves in spite of the deaths of 100 million White Christians during these events. However during these years, the Jew had also come to control another important tool in his arsenal against Christendom: the fledgling mass media, and Jewish capital insured that its power was concentrated in Jewish hands. Once Whites finished slaughtering each other, it was no mistake that the so-called "Civil Rights" and mass immigration movements began. And not only were the negroes and other aliens suddenly the possessors of the same rights as Whites, but now they were given legislated advantages above Whites. In the years to follow, contrived tales and television mega-productions such *Roots* not only paved the way for the rewriting of American history, but also inculcated in all Whites a shameful guilt over a slave trade which very few Whites ever actually had any part in. In fact, a real examination of history proves that the major participants in and benefactors of the slave trade were indeed the Jews themselves.

From the 1950's onward Whites have been bombarded with an ever-increasing barrage of Jewish propaganda aimed at exalting non-Whites, and especially negroes, in Western society. First it was in music and sports, but now it is in virtually every facet of life, that the negro has been purposely elevated to positions far above his actual competence. One recent manifestation of this is the Hollywood movie, *Red Tails*. Perhaps the title is an appropriate play on words for what it really is, and *Red Tales* would be far more accurate. The movie's propaganda states that "To help win the war, the Pentagon brass has no choice but to consider the untested African-American pilots of the experimental Tuskegee training program. Just as the young Tuskegee men are about to be shut down and shipped back home, they are given the ultimate chance to show their courage. These intrepid young airmen take to the skies to fight for their country - and the fate of the free world." However none of this is true, and the so-called Tuskegee airmen had absolutely no effect at all on the outcome of the war. They were really just a product of the "red" Roosevelt Administration's efforts to normalize the presence of negroes in the military. There were no truly distinguished negro pilots then, just as there have been



no truly distinguished negro pilots since.

As published in the [American Free Press](#) and elsewhere, real World War Two historians (not Jewish Hollywood propagandists and paid shells) have pointed out that the record of the Tuskegee airmen has been grossly exaggerated for the movie, and is now being peddled as history to the pliant and ignorant masses. Their real record in the relatively few (311) missions that they actually flew was rather dismal where records may be compared to those of other World War Two air squadrons. World War Two historian and author Robert H. Powell says the following: “Although I do not have complete combat statistics on all the fighter groups flying out of Africa and Italy (the MTO), I do have the stats on all of the 16 fighter groups flying in the Eighth Air Force over western Europe. And, when these records are compared, the Tuskegee Airmen rank at the bottom of the list despite the fact that they had four squadrons to only three for the 8th Air Force groups....and one of the reasons the Tuskegee Airmen exploit their 15,000+ sorties (which they call missions) is that on a normal mission they would put up 64 fighters compared to only 48 for the 8th Air Force groups. And, since they did mostly ground support missions rather than bomber escort missions, the average length of their missions was about half that of the time in the air flown by the 8th Air Force fighters.” The oldest book published about the Tuskegee Airmen in the list of references given on the recently-edited Wikipedia page concerning them is from 1980. Therefore if the Tuskegee Airmen actually had any great contribution to the outcome of the war, liberals, Jews, Civil Rights activists, and the negroes themselves in all of their propaganda actually missed taking advantage of it for 35 years. Is that really a lost opportunity, or is it only that today their role is being exaggerated for political purposes, now that the degraded social and academic climate and the nearly total control by Jews over the mass media make it easier to do so without being challenged? The Bible tells us that it is the dragon which gives its power to the beast, and nowhere is that clearer than in observing the relationship between the Jewish-controlled media-entertainment complex and the negroes of America today. The media and entertainment industries are consistently portraying the American negro in the best possible light: sports stars, movie heroes, bright, witty, charming television personalities, yet in reality the elevation of negroes has been destroying White civilization at an ever-increasing rate. The major cities are all blighted high-crime areas, and many of the the suburbs are not far behind. Over thirty-five thousand White women are raped by negroes in America each year, and not even ten black women in any given year are raped by Whites. Which group is it that really needs special legislative protection from the other? In several major urban centers these past two years, and especially in Philadelphia, violent black-on-White crime has been raising at an alarming rate, and the national media has purposefully ignored the situation. In Wisconsin this summer negroes interrupted the State Fair with violent random attacks on Whites which were clearly racially motivated.

This year alone in Philadelphia, there have been many dozens of reported incidents of black flash mobs perpetrating vicious acts against White persons and businesses, and seemingly random black-on-White beatings conducted by smaller groups of roving negroes, which the established media and government officials refuse to treat as a race problem, and especially refuse to treat as hate crimes or civil rights violations. If these same crimes had been committed by Whites against blacks, the Jewish media and Jewish and black civil rights group would be swarming the city with incessant demands for immediate “justice”, and federal civil rights prosecutors would be all over the media.

But the bottom line is this: if the media reports the truth about black-on-White crime, then Whites would react by withdrawing from and rejecting blacks. That would work contrary to the Jewish agenda, which has been working quite hard in order to condition Whites into accepting negroes these past hundred years. It took a long time for the Jewish media, sports and entertainment industries to be able to elevate the lowly and beastly negro to the point in society where he is today, and they are not going to spoil all of their “progress” by putting the truth about race and crime in their “news”. Truth in advertising, in this instance, would be very damaging to the Jewish political agenda. When it

is reported, it is only reported locally, and never described with the racial terms characteristic of the incidents. The perpetrators are not black, they are merely “teens” and “youths”.

In demonstrating that it is indeed the Jew who is responsible for the enshrinement of the negro in today's society, there is no recent event so signal as the very recent “crowning” of the so-called “Bishop” Eddie Long by a group of “Messianic” Jews in a church ceremony in Atlanta recently. As the *Atlanta Journal-Constitution* reported: “A ceremony held Sunday at New Birth Missionary Baptist Church, in which Bishop Eddie Long was wrapped in a sacred Torah scroll and carried upon a throne, has the Internet abuzz and Jewish religious leaders offended and questioning its appropriateness. 'He's a king. God has blessed him,' said Rabbi Ralph Messer before covering Long in a scroll [that] may still have the dust of Auschwitz and Birkenau.' Messer referred to the Nazi extermination camps in Poland where millions of Jews were murdered during the Holocaust.” Of course, Messer found some way to include a mention of the supposed “holocaust” in the presentation. One may imagine that the Jews could find a way to mention the “holocaust” in connection with just about anything.

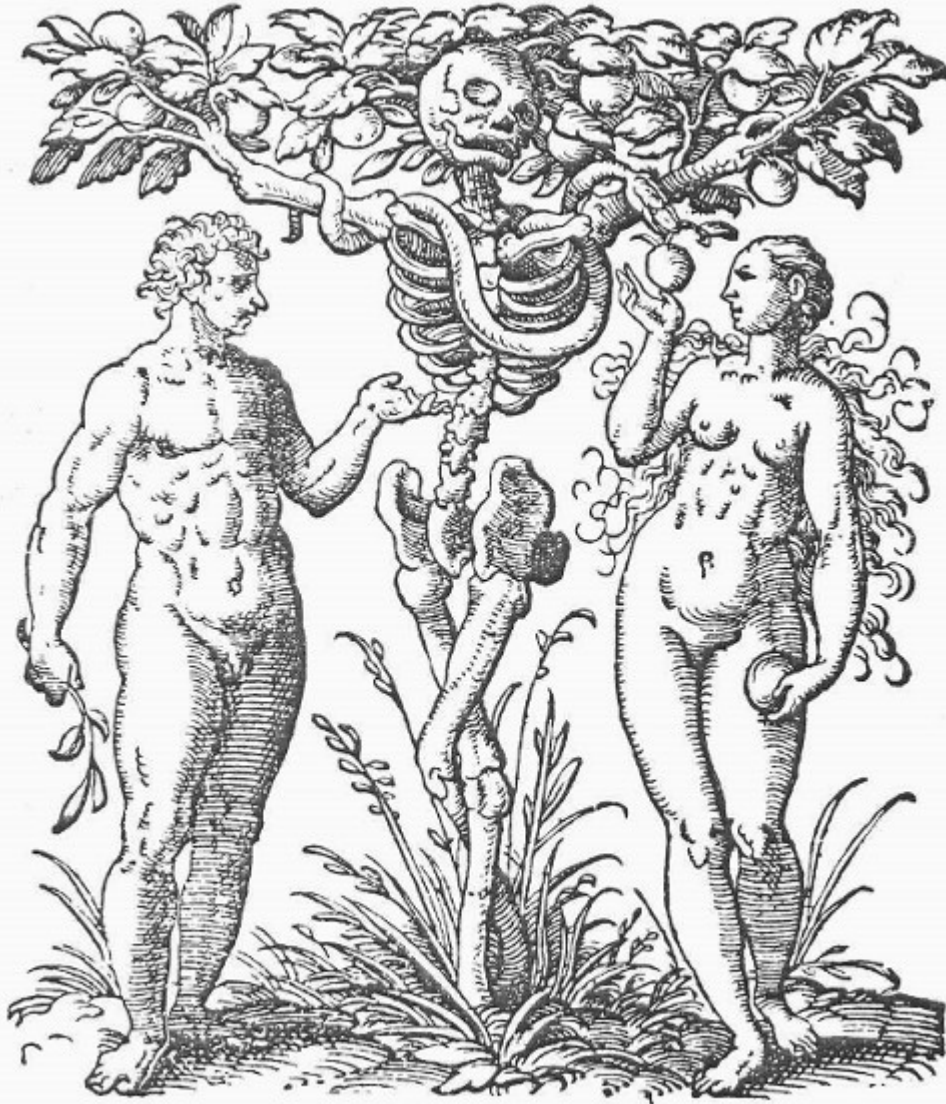


But there is yet one more aspect of the story, because Eddie Long is not just *any* negro cleric. He and his church recently settled out-of-court a lawsuit alleging that he used his office to force four under-aged male negro youths into sexual improprieties. The settlement was valued at 24.8 million dollars. Evidently, there is no known criminal investigation underway, although media outlets in Atlanta have inquired with the various law enforcement agencies. Long was offered a settlement of \$2 million, but when he refused to publicly admit guilt, the plaintiffs forced the much larger settlement. So the Jew Messer has coronated a negro preacher, who also happens to be a perverted pedophile, to be a “king”.

Of course, some Jewish groups protested Messer's actions, but not because Messer was bold enough to crown Long a “king” (which he made excuses for later), and not because Long's personal conduct made him unworthy of any religious distinction whatsoever, but only because of the way in which Messer used a certain torah scroll during the ceremony. So the Jews who voiced opposition to Messer only opposed the way he used an [allegedly] old piece of paper, and not because he placed a negro pervert on a pedestal.

Thus is the condition of western society today, where the Jew has rewritten history, and has elevated the negro and every other beast to positions of veneration in movies, in sports, and in all other areas of public life. And with that, negroes have found their way into the average White home, and the average White bedroom. Thus is the White man worshipping the beast, who gets his power from the dragon.

The Revelation of Yahshua Christ

Chapters 4 & 5

IV 1 After these things I looked, and behold! A door being opened in heaven, and the first voice which I had heard as a trumpet speaking with me saying “Come up here, and I shall show to you the things which are necessary to happen.” After these things

After having received the messages to the seven assemblies John receives another vision. In this vision John had an experience which describes his spirit actually having left his body, much as we see inferred by Paul in 2 Corinthians Chapter 12, where he described a vision and related that he could not tell whether it happened while he was in his body or out of it. Earlier in that same epistle Paul explained that to be in the body, we are away from God, and to be separated from our body is to be with God. Therefore Christians should not fear death: it is our gateway to our destiny and out true reality.



2 immediately I was in the Spirit, and behold! A throne fixed in heaven, and He sitting upon the throne. 3 And He sitting alike in appearance to a jasper stone, and a sardius, and a rainbow around the throne alike in appearance to emerald, 4 and around the throne twenty-four thrones, and upon the thrones twenty-four elders sitting, cloaked in white garments and upon their heads gold crowns. 5 And going out from the throne stars and voices and thunders, and seven lamps of fire burning before the throne, which are the seven Spirits of Yahweh, 6 and before the throne as a sea of glass like crystal. And in the midst of the throne and around the throne four living creatures full of eyes in front and behind. 7 And the first living creature like a lion, and the second living creature like a young bull, and the third living creature having a face as a man, and the fourth living creature like a flying eagle. 8 And the four living creatures, each one of them

having six wings above, full of eyes all around and within, and they do not have rest, day and night saying “Holy, holy, holy, Prince Yahweh Almighty, who was and who is and who is coming!”

The living creatures are actually cherubs, those chimerical sphinx-like creatures made up of the symbols of the four leading tribes of Israel, man, lion, bull and eagle. They are often depicted in association with the throne of Yahweh, as they are in Ezekiel Chapter 1, and they adorned the ark of the covenant.

Matthew 19:28: “28 And Yahshua said to them: “Truly I say to you that you are those who shall be following Me in the regeneration, when the Son of Man shall sit upon the throne of His honor, and you also shall sit upon twelve thrones judging the twelve tribes of Israel! ” Yet this does not limit the

number of thrones to twelve, and here we see that there are twenty-four. It is often conjectured that these other twelve are for the original patriarchs of Israel. Yet where are the other more prominent patriarchs, Abraham and Isaak and Jakob and Enoch and the others? I would rather think that the numbers are not to be taken literally, but to be seen symbolically. The twelve thrones for the apostles and the reserved number of twelve for the patriarchs of the Israelites is yet another assurance that the Dispensationalists are fools, and that the New Testament and Old alike are two halves of one book, reserved for one people.

9 And whenever the living creatures give honor and dignity and gratitude to Him sitting upon the throne, to He who lives for the eternal ages, 10 the twenty-four elders fall before Him sitting upon the throne and they worship He who lives for the eternal ages and they cast their crowns

before the throne, saying

11 “You are worthy, our Prince and God, to receive honor and dignity and power, because You have created all things and by Your will were they then created!”

The throne is the throne of Yahshua Christ, King of Kings who is to rule all of the nations. Here he is revealed – once again in Scripture – as being one and the same with Yahweh the Creator Himself. Whem His people overcome, they are given to rule with Him.

Chapter 5

V 1 And I saw at the right hand of Him sitting upon the throne a scroll, written on the inside and on the back, having been sealed with seven seals. 2 And I saw a mighty messenger proclaiming with a great voice: “Who is worthy to open the scroll and to loosen its seven seals?” 3 And no one was able in heaven nor upon the earth nor under the earth to open the scroll or to see it. 4 And I wept much, because no one is found worthy to open the scroll or to see it. 5 And one from among the elders says to me: “Weep not! Behold! The lion of the tribe of Judah, the root of David, has prevailed to open the scroll and its seven seals!”

Yahshua Christ is the Lion of Judah and He is also the root of David. This is the Christian Paradox, and it has been argued since the time of Christ: For that

reason Christ asked the Pharisees “If David then call him Lord, how is he his son?”, as we see recorded at Matthew 22:45. That He is God, Yahweh Himself having come as one of His own sons, is the only way that He could possibly be both the Root and the Offspring of David (cf. Isaiah 11:1, 10, Rev. 22:16). Of all of the sons of Adam, only Yahshua is worthy to open the seven seals, because



only Yahshua is blameless and only Yahshua is God. Only God Himself can see the future.

KJV Isaiah 11:1, 10: “And there shall come forth a rod out of the stem of Jesse, and a Branch shall grow out of his roots ... 10 And in that day there shall be a root of Jesse, which shall stand for an ensign of the people; to it shall the Gentiles seek: and his rest shall be glorious.”

KJV Rev. 22:16: “I Jesus have sent mine angel to testify unto you these things in the churches. I am the root and the offspring of David, and the bright and morning star.”

There are a few profane commentators who would pervert Revelation 5:5 into saying something differently, such as that the “lion of Judah” does not refer to Christ, and that it is somehow the object of a verb rather than the subject. Yet all of the Greek manuscripts, without exception, have the entire clause “the lion of the tribe of Judah, the root of David” in the Nominative case, making the entire clause the subject of the verb, and no part of it could possibly be an object of the verb. It is also a grammatical device by which both phrases are

meant to refer to the same entity. A modern equivalent would be a sentence such as “Today in the Big Apple, New York City, all of the airports were closed...” where we see that the phrase “Big Apple” is a synonym for and a reference to “New York City”. Only someone with an agenda, rather than the truth, could read Revelation 5:5 any

other way: The King James Version has this verse translated properly.

6 And I saw in the midst of the throne and of the four living creatures and in the midst of the elders a Lamb standing as if having been slaughtered, having seven horns and seven eyes which are the seven Spirits of Yahweh having been sent out into all the earth. 7 And He came

and received it from the right hand of Him sitting upon the throne.

The Lamb that appeared as if it had been slaughtered can only be Yahshua Christ, the Lamb of God, for which see John 1:29 and 1:36 where John the Baptist proclaims Him to be that very thing. Here the Lamb is symbolic, and this allegory also equates Christ to Yahweh, since He is depicted as having the seven spirits of Yahweh. That Yahweh which sits upon the throne is the Creator God who permeates the universe, while the Lamb is His physical manifestation.

KJV John 1:29: “The next day John seeth Jesus coming unto him, and saith, Behold the Lamb of God, which taketh away the sin of the world.”

KJV John 1:35-36:

“Again the next day after John stood, and two of his disciples ... And looking upon Jesus as he walked, he saith, Behold the Lamb of God!”

The four living creatures are described much the same way Ezekiel described them as a part of the throne of Yahweh 700 years prior to John.

These are the same as the cherubs which sat upon the ark of the covenant, those sphinx-like creatures which had the attributes of a man, a lion, a bull and an eagle, the symbols from the standards of the four leading tribes of Israel.

Ezekiel 1:4-11 KJV: “4 And I looked, and, behold, a whirlwind came out of the north, a great cloud, and a fire infolding itself, and a brightness was about it, and out of the midst thereof as the colour of amber, out of the midst of the fire. 5 Also out of the midst thereof came the likeness of four living creatures. And this was their appearance; they had the likeness of a man. 6 And every one had four faces, and every one had four wings. 7 And their feet were straight feet; and the sole of their feet was like the sole of a calf's foot: and they sparkled like the colour of burnished brass. 8 And they had the hands of a man under their wings on their four sides; and they four had their faces and their wings. 9 Their wings were joined one to another; they

turned not when they went; they went every one straight forward. 10 As for the likeness of their faces, they four had the face of a man, and the face of a lion, on the right side: and they four had the face of an ox on the left side; they four also had the face of an eagle. 11 Thus were their faces: and their wings were stretched upward; two wings of every one were joined one to another, and two covered their bodies.”

8 And when He received the scroll, the four living creatures and the twenty-four elders fell before the Lamb each having a lyre and golden bowls full of incense, which are the prayers of the saints, 9 and they sang a new song, saying “You are worthy to receive the scroll and to open its seven seals, because You have been slaughtered and You have purchased for Yahweh with Your

blood out of each tribe and tongue and people and nation 10 and have made them a kingdom and priests for our God, and they shall rule over the earth!”

Kinsman Redemption:

The purchase with blood for one's brethren is the ancient Hebrew law of the kinsman redeemer.

And if you are not a kinsman to the Redeemer, you have no part with Him in the first place! We see this in the Law at Leviticus 25:47-49 where the KJV has: “47 And if a sojourner or stranger wax rich by thee, and thy brother that dwelleth by him wax poor, and sell himself unto the stranger or sojourner by thee, or to the stock of the stranger's family: 48 After that he is sold he may be redeemed again; one of his brethren may redeem him: 49 Either his uncle, or his uncle's son, may redeem him, or any that is nigh of kin unto him of his family may redeem him; or if he be able, he may redeem himself.”

Related Scriptures abound in both the Old and New Testaments, and the Old Testament passages referenced below all use a specific word which the KJV usually translates into a simple word, *to redeem*, yet there is a much greater meaning in the underlying Hebrew. The word is *ga'al*, Strong's no. 1350, and Strong defines it thus: “... to *redeem*



(according to the Oriental law of kinship), i.e. to *be the next of kin* (and as such to *buy back* a relative's property, *marry* his widow, etc.)..." As Strong's also attests, the King James Version has also translated the word to reflect all of these meanings in certain contexts in the Old Testament.

KJV Leviticus 25:25: "If thy brother be waxen poor, and hath sold away some of his possession, and if any of his kin come to redeem it, then shall he redeem [as a kinsman] that which his brother sold."

KJV Psalm 74:2: "Remember thy congregation which thou hast purchased of old; the rod of thine inheritance, which thou hast redeemed [as a kinsman]; this mount Zion, wherein thou hast dwelt."

KJV Psalm 107:2: "Let the redeemed [kinsmen] of Yahweh say so, whom he hath redeemed [as a kinsman] from the hand of the enemy."

KJV Isaiah 43:1: "But now thus saith Yahweh that created thee, O Jacob, and he that formed thee, O Israel, Fear not: for I have [as a kinsman] redeemed thee, I have called thee by thy name; thou art mine."

KJV Isaiah 62:12: "And they shall call them, The holy people, The redeemed [by their kinsman] of Yahweh: and thou shalt be called, Sought out, A city not forsaken." (*Sought out* must refer to the "hunters" of Jeremiah 16:16.)

The idea that Israel was sold in sin, and therefore Israel had to be redeemed, is also found explicitly in Scripture, for instance at Isaiah 50:1 and 52:3, which is also a Messianic prophecy.

KJV Isaiah 50:1: "Thus saith the LORD, Where is the bill of your mother's divorcement, whom I have put away? or which of my creditors is it to whom I have sold you? Behold, for your iniquities have ye sold yourselves, and for your transgressions is your mother put away."

KJV Isaiah 52:3: For thus saith the LORD, Ye have sold yourselves for nought; and ye shall be redeemed [by a kinsman] without money.

KJV Romans 7:14: "For we know that the law is spiritual: but I am carnal, sold under sin."

Therefore Paul, in Galatians Chapter 4, gives the

very reason why Christ came to die on the cross in the first place, giving His blood as the price for His redemption of this same Israel people. Once this understanding is obtained, once and for all the Old Testament and the New clearly converge as one and the same book telling a consistent story from cover to cover.

CNT Galatians 4:4-5: "4 And when the fulfillment of the time had come, Yahweh had dispatched His Son, having been born of a woman, having been subject to law, 5 in order that he would redeem those subject to law, that we would recover the position of sons." (See also Luke 1:68, 24:21; Galatians 3:13; 1 Peter 1:18; Revelation 14:3, 4.)

A Kingdom of Priests

The idea of a "Christian priest" does not exist in the ante-Nicene writers, because all Christians should be priests in their own right, and there should be no professional Christian priesthood.

Those who do the will of God are doing the service to God that He requires and therefore they are all priests of God.

There is nothing in Christianity which requires that performance of any special ritual. We are merely told to keep His commandments and to love our brethren – in action and not in speech only – and by doing those things we achieve the execution of the true Christian priesthood. The idea that each and every Israelite who does the will of Yahweh is a priest of Yahweh belongs to the Old Testament as well as the New, and is evident from Exodus Chapter 19 as well as from the epistles of Peter, Paul, and elsewhere in the Revelation.

While Paul does not refer to this priesthood status of Christians explicitly, in those letters which we have he does often use the Greek word *leitourgia*, and words related to it, in reference to the deeds which common Christian people perform in obligation of their duties to God. Yet the meaning of this word, which bears the very meaning of *a service performed for God*, is hidden in translation. The professional priesthood has adopted it for their own purposes, where they merely transliterate it as

liturgy. In Athens, the word was used to describe those services which men either chose or were elected to freely provide for the public. When Christians provide for their brethren, that is their liturgy and they are fulfilling their Christian priesthood!

KJV Exodus 19:5-6: “Now therefore, if ye will obey my voice indeed, and keep my covenant, then ye shall be a peculiar treasure unto me above all people: for all the earth is mine: And ye shall be unto me a kingdom of priests, and an holy nation. These are the words which thou shalt speak unto the children of Israel.”

KJV 1 Peter 2:5, 9: “Ye also, as lively stones, are built up a spiritual house, an holy priesthood, to offer up spiritual sacrifices, acceptable to God by Jesus Christ.... But ye are a chosen generation, a royal priesthood, an holy nation, a peculiar people; that ye should shew forth the praises of him who hath called you out of darkness into his marvelous light...”


KJV Rev. 1:6: “And hath made us kings and priests unto God and his Father; to him be glory and dominion for ever and ever.”

11 And I looked, and heard a sound of many messengers around the throne, and of the living creatures and of the elders, and the number of them was ten thousands of ten thousands and thousands of thousands 12 saying with a great voice: “Worthy is the Lamb which had been slaughtered to receive power and wealth and wisdom and strength and dignity and honor and praise!” 13 And every creature which is in heaven and upon the earth and under the earth

and upon the sea and the things in them all heard, saying: “To Him sitting upon the throne and to the Lamb is the praise and the dignity and the honor and the sovereignty for the eternal ages!” 14 And the four living creatures said “Truly!” And the elders fell down and they worshipped.

The ten thousands of ten thousands must be a vision of the saints – or holy ones – of Yahweh, the redeemed of our race, which we shall see mentioned more often in the chapters which follow. As we see where Jude quotes the writings of Enoch, when Yahshua returns He comes “with ten thousands of his saints, To execute judgment upon all, and to convince all that are ungodly among them of all their ungodly deeds which they have ungodly committed, and of all their hard speeches which ungodly sinners have spoken against him” (Jude 14, 15). Here we have a profession of those very same people, which at one time rejected Yahweh as their King, that indeed He is sovereign and rightfully so, for only Yahweh Himself can justly rule over His people.

In 1 Samuel Chapter 8 we see that the children of Israel demanded an earthly king, thereby rejecting the Sovereignty of Yahweh their God. This is summarized in 1 Samuel 10:19 thus: “And ye have this day rejected your God, who himself saved you out of all your adversities and your tribulations; and ye have said unto him, Nay, but set a king over us. Now therefore present yourselves before the LORD by your tribes, and by your thousands.” This is truly the “Stone which the builders rejected”, and in Christ it will once again become the *chief cornerstone*.

To All Those Who Deny Two Seedline Part Nine C A Emahiser

This matter of Two Seedline is of the utmost importance in our day, for we are beginning to see the culmination of this age-old “enmity”. While it has been festering just below the surface for several thousands of years, today it is reaching its peak. It’s like a giant abscess spewing out its foul, infectious, corrupt, putrefying poison. And, while these great evil underground forces are at work, churchianity sits idly on the sidelines pretending all is well. In fact, the infection is seeping into their midst, and they consider it “Christian.” Worse still, the anti-seedliners disavow the cause. To the anti-seedliners, it’s just a theological game of words. They simply haven’t done their homework on the subject.

To illustrate this, I will quote excerpts from Dr. Lightfoot in his *A Commentary on the New Testament from the Talmud and Hebraica*, volume 2, pages 367-369 concerning Matthew 27:38-46:

“Among the monsters of the Jewish routs, preceding the destruction of the city, the multitude of robbers, and the horrible slaughters committed by them, deservedly claim the first consideration; which, next to the just vengeance of God against that most wicked nation, you may justly ascribe to divers originals. 1. It is no wonder, if that nation abounded beyond measure with a vagabond, dissolute, and lewd sort of young men; since, by means of polygamy, and the divorces of their wives at pleasure, and the nation’s unspeakable addictedness to lasciviousness and whoredoms, there could not but continually spring up **bastards**, and an offspring born only to beggary or rapine, as wanting both sustenance and ingenuous education. 2. The foolish and sinful indulgence of the council could not but nurse up all kind of **broods of wicked men**, while they scarce ever put any one to death, though never so wicked, as being an Israelite [Jew]; who must not by any means be touched ... All the rout indeed and force of hell was let loose at that time against Christ, without either bridle or chain: he calls it himself ... *the power of darkness*, Luke 22:53. God who had foretold of old, that the serpent should bruise the heel of the promised seed, and now that time is come, had slackened the devil’s chain, which, in regard of men, the Divine Providence used to hold in his hand; so that all the power and all the rancour of hell might, freely and without restraint, assault Christ; and that all that malice that was in the devil against the whole elect

of God, [would be] summed up and gathered together into one head, might at one stroke and onset be brandished against Christ without measure.”

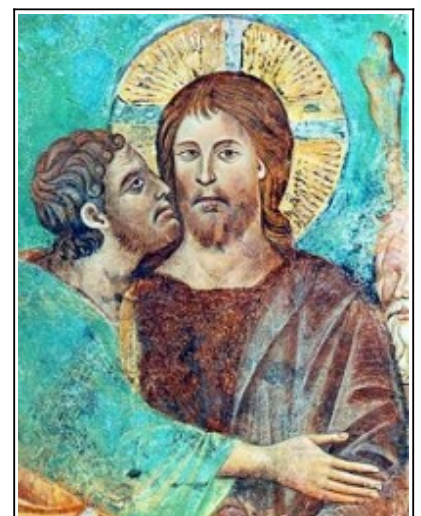
If you listen to the anti-seedliners, they will claim there was “no power of hell” at work in the Crucifixion of the Messiah. They delegate all of that to some kind of “spiritual” hocus-pocus, making mockery of the tenets of Scripture. I addressed this subject of the “bruising of Messiah’s heel” in my *Research Papers Proving The Two Seedline Seduction Of Eve*. This passage, by Dr. Lightfoot, vindicates what I said in that article:

Yahshua's Heel Bruised by Judas

“We have a direct connection, here, with Judas, and the ‘serpent’ of Genesis 3:14-15! We can see the connection between Judas and the ‘serpent’, if we read

John 13:18:

“I speak not of you all: I know whom I have chosen: but that the scripture may be fulfilled, He that eateth bread with me hath lifted up his HEEL against me.”



“The scripture spoken of here, which was fulfilled in Judas, was Genesis 3:15! Does that

sound ‘spiritual’? Judas was a Kenite-Canaanite ‘Jew-devil’, a descendant of Cain fathered by Satan! However, there is a problem here because it says that ‘he (Judas) hath lifted up his heel against me’ whereas Genesis 3:15 says that ‘thou (the seed of the serpent) shalt bruise his (Yahshua’s) heel.’ Is it the ‘heel’ of Judas or Yahshua that is affected? I am quite certain that John 13:18 is referring to Genesis 3:15, as it is indicating that it is a fulfillment of Scripture. Tell me, what other Scripture could it be? — there isn’t any. There is another Scripture, Psalm 41:9, that reads similarly to John 13:18, but John 13:18 is not a fulfillment of Psalm 41:9 — as a matter of fact, Psalm 41:9 is not a prophecy about anything. The prophecy then can only be Genesis 3:15! — and Genesis 3:15 is definitely a prophecy. Therefore, there has to be a slight mistranslation in Genesis 3:15! Let’s try to render it in a manner which makes some sense:

“And I will put enmity between thee and the woman, and between thy seed and her seed; it (her seed) shall bruise thy head and thy heel shall (rise up and) bruise him (her seed).”



“It’s not the seed of the serpent that was to bruise the heel of Yahshua, but the seed of the serpent will lift up his heel and bruise Yahshua (the seed of the woman). Now, Yahshua is not the only seed of the woman. All of Eve’s descendants are the seed of the woman. Once we understand that it is the seed of the serpent (in the person of Judas) that was to lift up his heel against the Messiah, we can better understand Isaiah 53:5:

“But he was wounded for our transgressions, he was bruised for our iniquities: the chastisement of our peace was upon him; and with his stripes we are healed.”

“One good comment on John 13:18, is from the Jamieson, Fausset & Brown *Commentary On The Whole Bible*, page 1058:

“I speak not of you all — the ‘happy are ye,’ of vs. 17, being on no supposition applicable to Judas. I know whom I have chosen —in the *higher* sense. But that the scripture may be fulfilled —i.e., one has been added to your number, by no accident or mistake, who is none of Mine, but just that he might fulfil his predicted destiny. He that eateth bread with me — ‘did eat of *my bread*.’”

“It was Judas that raised up his heel against Him and bruised Him. It probably should be pointed out here what is meant by ‘lifting up the heel.’ It is described as someone who kicks out at the person who is feeding him. Judas, planning to betray Yahshua while eating of the sacrificial supper, did just that, and it is known as ‘lifting up the heel.’ This ‘heel’ in John 13:18 is the same ‘heel’ as in Genesis 3:15. This type of action was considered one of the most insulting things a man could do. Of course, what else would you expect of a devil?

“Just before this ‘lifting up the heel’ on the part of Judas by partaking of the last supper, some interesting statements are made. They were having a foot washing lesson from Yahshua. Verse 10 says, **‘Yahshua saith to him, He that is washed needeth not save to wash *his* feet, but is clean (pure) every whit: and ye are clean (pure), but not all.’** Yahshua is indicating that all the disciples are clean (pure) racially, but no amount of washing would make Judas clean (pure).

“A second statement in this 18th verse is also interesting. It says, **‘I speak not of you all.’** Again Yahshua is excluding Judas from the others. **‘I know whom I have chosen.’** I am not deceived in My choice. I knew what was going to happen from the very beginning of the enmity of the serpent. I have chosen Judas as a ‘serpent’ and I plainly foresaw that he would raise up the heel and deliver Me. Did not I foretell this at the time of the curse upon the ‘serpent’? Matthew 26:14-16:

“14 Then one of the twelve, called Judas Iscariot, went unto the chief priests, 15 And said unto them, What will ye give me, and I will deliver him unto you? And they covenanted with him for thirty pieces of silver. 16 And from that time he sought opportunity to betray him.”

“If you can’t see ‘Jew’ written all over this action on the part of this ‘serpent’, Judas, you have to be blind. He was only doing his father’s bidding, John 12:4-6:

“4 Then saith one of his disciples, Judas Iscariot, Simon’s son, which should betray him, 5 Why was not this ointment sold for three hundred pence, and given to the poor? 6 This he said, not that he cared for the poor, but because he was a thief and had the bag, and bare what was put therein.

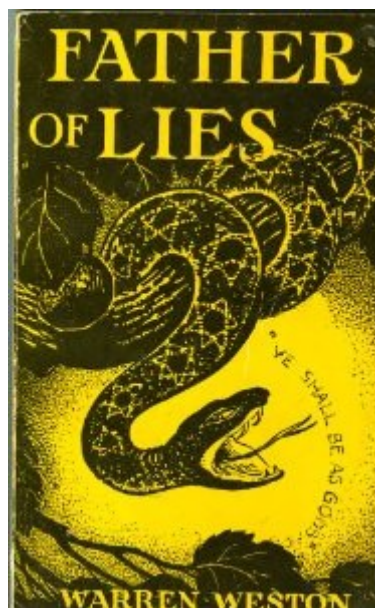
“Not only was this ‘serpent-Jew’ a traitor, he was a thief — just like the ‘Jewish’ IRS and Federal Reserve of today. Here is more evidence that Judas was the offspring of Satan ...

“Like the Spirit that is within Yahweh’s children (seed of the woman), so there is a counter-spirit within the ‘serpent’s’ children. That is why it just came natural for Judas to betray Yahshua. It says here that the devil put it into the heart of Judas to betray the Messiah. The children of Satan have a certain nature about them, and under various circumstances, they will react in predictable behavior patterns. The Messiah understood exactly what the behavior pattern of the ‘serpent’, Judas, would be. That behavior pattern is yet more evidence that the ‘Jews’ are a Satanic seedline. You cannot change the nature of a rattlesnake, nor can you change the nature of a ‘Jew.’ So much for ‘Jews for Jesus!’” (See also Jeremiah 13:23)

All this is totally oblivious to the anti-seedliners! Speaking further on page 83 of volume 2, Lightfoot says of that nation: “That the nation, under the second Temple was given to magical arts beyond measure ... That it was given to easiness of believing all manner of delusions beyond measure. And one may safely suspect, that those voices which they thought to be from heaven, and noted with the name *Bath Kol*, were either formed by the devil in the air to deceive the people, or by magicians by devilish art to promote their own affairs ... The very same which I judge of the *Bath Kol*, is [in] my opinion also of the frequent appearances of Elias, with which the leaves of the Talmud do every where abound; namely, that in very many places the stories are false, and, in the rest, the apparitions of him were diabolical.”

The “magical arts” used by the “Jews” is

called the “Cabala” (sometimes spelled Cabbala, Kabbalah or Qabbalah). According to Warren Weston in his *Father Of Lies*, page 51: “The four collections of works composing the Dogmatic Kabbalah are: 1. The Sepher Yetzirah, or ‘Book of the Formation’: it treats of the cosmogony as symbolized by ten members and twenty-two letters of the Hebrew alphabet, which it calls the ‘thirty-two paths’ or symbols,— with the esoteric zero making thirty-three in all ... The whole Kabbalah is usually classed under four heads:



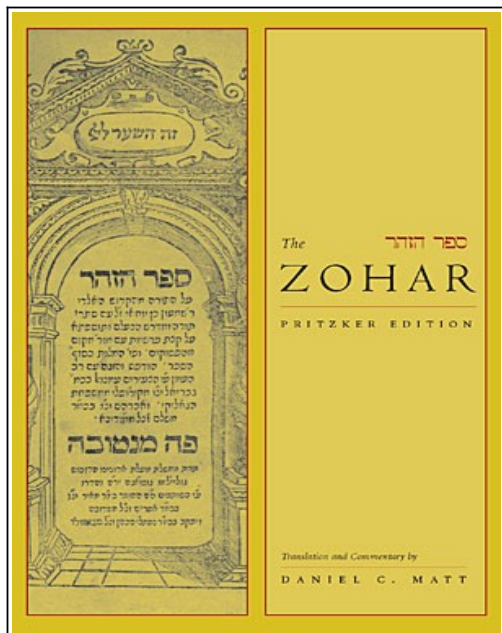
(1) The Practical Kabbalah. (2) The Literal Kabbalah. (3) The Unwritten Kabbalah. (4) The Dogmatic Kabbalah ... 2. The Zohar, or book of ‘Splendour’, itself composed of five important books (besides other treatises) ... These five are: Siphra Dtzenioutha, or ‘Book of Concealed Mystery’; Idra Rabba

Qadisha, or ‘Greater Holy Assembly’; Idra Zuta Qadisha, or ‘Lesser Holy Assembly’; Beth Elohim, or ‘House of the Elohim’; and the ‘Book of the Revolutions of the Soul.’ 3. The Sepher Sephiroth, or ‘Book of Numbers’ (or Emanations) ... Sephira, ‘number’ (singular); Sephiroth (plural). 4. The Asch Metzareph, or ‘Purifying Fire’, dealing with Alchemy.”

While a good deal of the *form* of the Cabala can be traced to the second century, the *substance* appears to originate from remote antiquity, possibly as remote as Cain. In the book *Trail of the Serpent* by Miss Stoddard, page 25, the Cabala is described: “The Practical or Magical Cabala with its combinations and correspondences was the astrological, magical, and magnetic basis used by the Alchemists and Magicians of the Middle Ages in working their transmutations and conjurations. It was impregnated with the ‘fluidic magic’ derived from very ancient cults, and still practiced at the time of the Captivity among the Persians and Chaldeans. To-day, all Rosicrucians and cabalistic

sects use this Magical Cabala for their works of divining, clairvoyance, hypnotic and magnetic healing, making of talismans, and contacting their mysterious masters. As the Jewish writer Bernard Lazare said: ‘Secret societies represented the two sides of the Jewish mind, practical rationalism and pantheism, that pantheism which, metaphysical reflection of the belief in One God, ended at times in cabalistic theurgy’.”

Let us now see an example of what is contained in the Cabala. For this, I will now quote from *The Esoteric Tradition* by G. de Purucker, volume 1, page 62:



“Turning to the Jews, one may find in the *Zohar* — a Hebrew word meaning ‘splendor’, which is perhaps the greatest text-book of the Jewish Qabalah, and which has been mentioned before — a statement to the effect that the man who understands the Hebrew Bible in its literal meaning is a fool. ‘Every word of it’, says the *Zohar* in this connexion, ‘has a secret and sublime sense, which the wise [that is, the initiated] know.’ One of the greatest of the Jewish Rabbis of the Middle Ages, Maimonides, who died in 1204, writes:

“We should never take literally what is written in the Book of the Creation, nor hold the same ideas about it that the people hold. If it were otherwise, our learned ancient sages would not have been [sic. gone] to so great labor in order to conceal the real sense, and to hold before the vision of the uninstructed people the veil of allegory which conceals the truths that it contains. Taken literally,

that work contains the most absurd and far-fetched ideas of the Divine. Whoever can guess the real sense, ought to guard carefully his knowledge not to divulge it. This is a rule taught by our wise men, especially in connexion with the work of the six days ...”

It is true that the Bible is written, to a great degree, in allegory and symbols, and if we don’t understand them, we cannot grasp the message contained therein. The “Jews”, on the other hand, attach an occult meaning to every word and phrase. Their views of Scripture are so foreign to our perspectives one would not recognize them. In spite of this, their view is not always entirely incorrect. From the above, it is obvious that the “Jews” do not believe in a six, twenty-four hour day Creation as do some Christian fundamentalists! If we take the same stance as the anti-seedliners like Ted R. Weiland, Jeffrey A. Weakley, Stephen E. Jones, Jack Mohr, Charles Weisman, etc., that everything found in “Jewish” writings is evil, we will have to take the opposite position and start advocating a six, twenty-four hour day Creation also. Can you see now how absurd some of the positions taken by the anti-seedliners are? You will remember, as I showed you before, if we throw everything out which can be found in the *Talmud* and other “Jewish” writings, we will have to pitch out most of the contents of our Bibles, along with the truth of our Identity. One thing I have noticed with the anti-seedliners is: they are strangely quiet about “Jewish” history, and never seem to quote “Jewish” history books. This should run up a red flag for us, indicating they’re not as knowledgeable on the subject as they pretend to be. And that hardly qualifies them as students who have studied to show themselves approved, (2 Timothy 2:15). As I have said oft before, we need a Bible in one hand and a history book in the other (“Jewish” history books without exception).

Referring again to *A Commentary on the New testament from the Talmud and Hebraica* by John Lightfoot, volume 2, page 209: “That nation and generation might be called *adulterous* literally; for what else, I beseech you, was their irreligious polygamy than continual adultery? And what else was their ordinary practice of divorcing their wives, no less irreligious, according to every man’s foolish or naughty will?”

Proselytes for Gain

Again on Lightfoot, volume 2, pages 295-297 concerning Matthew 23:13-14: “Under a pretence of mighty devotion, but especially under the goodly show of long prayers, they so drew over the minds of devout persons to them, especially of women, and among them the richer widows, that by subtle attractives they either drew out or wrested away their goods and estates. Nor did they want nets of counterfeit authority, when from the chair they pronounced, according to their pleasures, of the dowry and estate befalling a widow, and assumed to themselves the power of determining concerning those things ...

“Yet in making of these they used their utmost endeavours for the sake of their own gain, that they might some way or other drain their purses, after they had drawn them in under the show of religion, or make some use or benefit to themselves by them. The same covetousness, therefore, under a veil of hypocrisy, in devouring widows’ houses, which our Savior condemned in the former clause, he here also condemns in hunting after *proselytes*; which the scribes and Pharisees were at all kind[s] of pains to bring over to them. Not that they cared for *proselytes*, whom they accounted as ‘a scab and plague’; but that the more they could draw over to their religion, the greater draught they should have for gain, and the more purses to fish in. These, therefore, being so proselyted, ‘they made doubly more the children of hell than themselves.’ For when they had drawn them into their net, having got their prey, they were no further concerned what became of them, so they got some benefit by them. They might perish in ignorance, superstition, atheism, and all kind[s] of wickedness: this was no matter of concern to the scribes and Pharisees; only let them remain in Judaism, that they might lord it over their consciences and purses.”

Arab Proselytes to Judaism

The main index of the *History Of The Jews* by Heinrich Graetz is found in volume 6, and on page 512 are listed the various peoples proselyted by the “Jews” during their extended history. The list is too extensive to elaborate on here. We will key in on volume 3, pages 60-62 concerning the subtitle “Arabs Become Converted To Judaism” (approximately 450-500 A.D.):



“Happily, the Arabian Jews bethought them of the genealogy of the Arabs as set forth in the first book of the Pentateuch, and seized upon it as the instrument by which to prove their kinship with them. The Jews were convinced that they were related to the Arabs on two sides, through Yoktan and through Ishmael. Under their instruction, therefore, the two principal Arabian tribes traced back the line of ancestors to these two progenitors, the real Arabs (the Himyarites) supposing themselves to be the descendants from Yoktan; the pseudo-Arabs in the north, on the other hand, deriving their origin from Ishmael. These points of contact granted, the Jews had ample opportunity to multiply the proofs of their relationship. The Arabs loved genealogical tables, and were delighted to be able to follow their descent and history so far into hoary antiquity; accordingly, all this appeared to them both evident and flattering. They consequently exerted themselves to bring their genealogical records and traditions into unison with the Biblical accounts. Although their traditions extended over less than six centuries on the one side to their progenitor Yarob and his sons or grandsons Himyar and Kachtan, and on the other, to Adnan, yet in their utter disregard of historical accuracy, this fact constituted no obstacle. Without a scruple, the southern Arabians called themselves Kachtanites, and the northern Arabians Ishmaelites. They readily accorded the Jews the rights of relationship, that is to say, equality and all the advantages attending it.

“The Arabs were thus in intimate intercourse with the Jews, and the sons of the desert whose unpoetical mythology afforded them no matter for inspiration, derived much instruction from Judaism. Under these circumstances many Arabs could not fail to develop peculiar affection for Judaism, and some embraced this religion, though their conversion had not been thought of by the Jews. As they had practiced circumcision while heathen, their

conversion to Judaism was particularly easy. The members of a family among the Arabs were indissolubly bound to one another, and, according to their phylarchic constitution, the individuals identified themselves with the tribe. This brought about, that when a chieftain became a Jew, his whole clan at once followed him, the wisest, into the fold of Judaism. It is expressly recorded about several Arabian tribes that they were converted to Judaism; such were the Benu-Kinanah, a warlike, quarrelsome clan, related to the most respected Koraishites of Mecca, and several other families of the tribes Aus and Chazaraj in Yathrib.

“Especially memorable, however, in the history of the Arabs is the conversion of the powerful king of Yemen. The princes or kings of Yemen bore the name of Tobba, and at times ruled over the whole of Arabia; they traced their historical origin back to Himyar, their legendary origin to Kachtan ...”

This is only one example of the extensive amount of “Jewish” proselytizing in history. This is the kind of history the anti-seedliners are mute on. Their incompetent, inept commentary bears record of their immaturity on the subject. You may think it is out-of-place for me to mention names of the anti-seedliners. Before I wrote one jot, Jeffery A. Weakley in his *The Satanic Seedline, Its Doctrine and History*, wrote this on page 29: “If you have en-

countered an argument and you are sincerely seeking an answer [against Two Seedline], I suggest that first you completely study it out in God’s Word (look up definitions, check parallel passages, be sure of the context, etc.). After that I suggest you contact men such as Pete Peters, Dan Gentry, Earl Jones, Jack Mohr, etc. ...” From Jeffery A.

Weakley’s comment, here, there can be little doubt where Pete Peters and the three others mentioned stand on Two Seedline! After Weakley, writing a book against the Two Seedline doctrine, you surely wouldn’t expect him to recommend someone who didn’t agree with him, would you? Jeffery A.

Weakley was an anti-seedliner, and he knew Pete Peters was an anti-seedliner also. To the date of this writing, there is no public evidence that Pete Peters has changed his position on the subject, and I don’t believe he ever will! 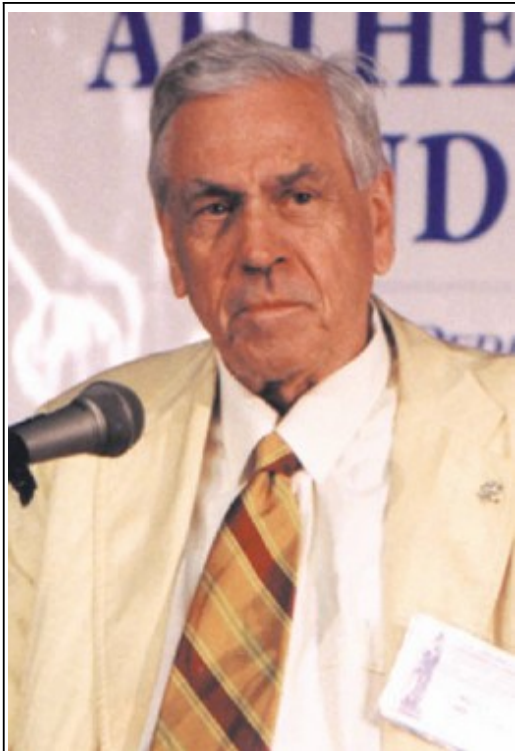

Boycott: The Jewish Weapon

In 1950, Senator Pat McCarran said to me, "If the American people ever find out what the Jews are doing to them, they won't leave a Jew alive from coast to coast." An official of the American Jewish Congress said "We must never lose sight of the fact that the only thing preventing pogroms in the United States today is our watchful control over the channels of communication." And in 1977 a Jewish columnist wrote, "We have been overthrown by the television show Roots, as many whites have been inculcated with feelings of shame, fear and guilt by this revelation of black history. This should warn us that we are sitting on a powder keg, if unfriendly elements should be allowed the chance to present the Jews in an unfavorable light on television. The success of Roots must reinforce our determination to deny native fascist elements any and all opportunities to use the media to spread their poison to impressionable Americans."

This fear among the Jews is real because the crimes of the Jews are real. As Senator McCarran pointed out to me the rage of Americans, once aroused by a factual chronicling of the of the Jews, would be

unleashed in one of the most terrible strokes of vengeance ever known.

We all know that the principal function of the United States Government today is to maintain Jewish dictatorship over the American workers. On every hand, American citizens groan under censorship, denial of civil rights and oppressive taxation which finances the genocide campaign of the Jews against the Arab people. We suffer the proliferation of government agents who force their way into every aspect of our private lives to enforce Jewish decrees against the people. How did the Jews attain this power? The record can be useful to us. A numerically small and physically weak group of parasites encysted itself in the main avenues of American life. By maintaining absolute discipline in their ranks, they seized control of the most powerful nation in the world. Always beginning in commerce, frequently by dealing in second-hand or stolen goods, they branched out into government, religion, education and communications. In every case, their gains were used to increase Jewish power over the people.

The fanatical self-discipline of the Jews is shown by their use of the boycott. In 1933, the German people democratically elected a non-Jewish government. During the 1920's, the Germans had suffered under a victorious Jewish government called the "Weimar Republic", which dominated every aspect of German life. The German people defeated this Jewish dictatorship in 1933 by voting against it. Immediately the Jews called a world conference in Amsterdam, the diamond capital of the world, forming the "Non-Sectarian Anti-Nazi League" with a multimillionaire Jewish lawyer from New York, Samuel Untermyer, as its president. Untermyer demanded a "sacred war" against Germany. The League was hardly non-sectarian, since it was one hundred per cent Jewish. Gentiles paid little attention to this declaration of war, not realizing it was the first shot of World War Two. They supposed that war meant armies marching against each other, and did not understand that for the Jew, life is war. He is born battling against the gentiles, and spends his entire lifetime in a state of war. Gentiles know little of the subterranean type of warfare waged

internationally by the Jew, in which poison, arson and murder are the most typical weapons.

While Untermeyer presided over the visible attack against Germany, a worldwide campaign of terrorism was launched against Germany by Vladimir Jabotinsky, founder of the Irgun Zvai Leumi, the terrorist wing of the Zionist movement. Jabotinsky's mastery of terrorism ensured the establishment of the State of Israel in 1948, and Jabotinsky became a respected member of the Israeli Parliament. In January 1934, Jabotinsky declared in his newspaper, Natcha Retch, "**The fight against Germany has been carried on for months by every Jewish community, conference, congress, trade organization, by every Jew in the world. Our Jewish interests demand the complete destruction of Germany.**"

This terrible outcry of hatred reveals the true nature of the Jew, whose motto of "Solidarity Forever" indicts their state of war against all civilized people. Jabotinsky is saying that no Jew can ever be a loyal citizen of any nation, because "our Jewish interests" take precedence over all other ties.

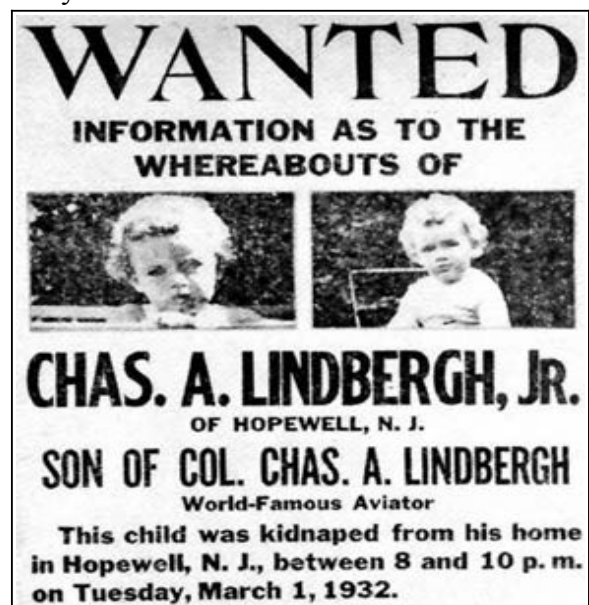
Despite this declaration of war by the Jews, Germany took no anti-Jewish measures for nearly five years, until provocateurs forced five to take steps to protect themselves. Max Warburg continued to reside unmolested, in Germany until 1939, when he packed his possessions and moved to New York. However, the worldwide boycott by the Jews against Germany, organized in 1933, had taken immediate effect. Such boycotts are illegal in the United States, because they comprise acts of "criminal syndicalism", the alliance of criminals to inflict damage upon others by criminal combinations. Nevertheless, the Jews, operating with complete freedom under Roosevelt's New Deal, or Jew Deal, as it was known to many Americans, conducted their illegal boycott openly, advertising the fact that they were in criminal restraint of trade. They carried on a national campaign of terrorism against anyone who dared to handle German goods. Since forty per cent of Americans were of German origin, one might suppose they would have little effect, but most of the German descendants joined in the boycott, hoping to prove that they were "good Americans". Operating on a multimillion dollar budget, the Non-Sectarian Anti-Nazi League poured forth a flood of publications from their headquarters in New York City. One such, The Idealist, in August 1937 carried

a front page list of merchants who were still handling German goods. These were small shops, as the large firms had long since yielded to vicious Jewish pressure and had agreed to boycott Germany. Another paper, the Anti-Nazi Bulletin, boasted in February 1939 that Germany would be brought to her knees by the worldwide Jewish boycott. It stated editorially, "The boycott is the solution, its effect as inexorable and inevitable as the march of time." A few months later, the German armies stood unchallenged as the masters of Europe, but the Jews could afford to wait.

Many Americans were horrified by the hate campaign of the Jews, realizing that the Jews were determined to use American youths in their war against Germany. One who dared to oppose them was America's greatest living hero, Charles Lindbergh.



Lindbergh's father, a Congressman during WW I, had his home broken into by federal agents and his books burned because he spoke out against the enactment of the Federal Reserve Act. In 1932 the Jews backing the Roosevelt campaign were terrified that Charles Lindbergh might decide to seek the office of President. Should this handsome blond hero, the most famous man in America; decide to run, the misshapen Roosevelt, crouching in his wheelchair, would not stand a chance. In March of 1932, Lindbergh's baby son was kidnapped and killed by ritual murder.

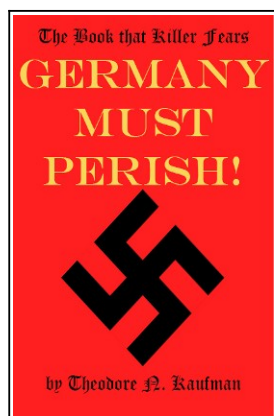


The sorrowing Lindbergh withdrew from public

life, and Roosevelt's campaign was secure. Years later, a German carpenter, Gerhart Hauptmann, was electrocuted for this murder. A recent book proves that the FBI fabricated the evidence which sent him to the electric chair, as a vital part of the Jews' Hate-Germany campaign. Another book proves that the Jews set fire to the Zeppelin Hindenburg in New Jersey, a few miles from the scene of the Lindbergh murder, which was touring here on a goodwill mission from Germany.

Knowing that the Jews intended to use American boys as cannon fodder to attack the non-Jewish government of Germany, Charles Lindbergh came forth as the leader of the American First movement. The Jews launched a national smear campaign against him, which continues to this day. During World II the Jews refused to allow him to serve as a commissioned officer in the armed forces, but he flew many missions as a "civilian observer" in the Pacific.

Few Americans today recall the unpleasant aspects of life during World II. Black markets flourished as the Jews made billions of dollars in profits from illegal sales of sugar, gasoline and other commodities. At the same time, they instituted tight rationing controls on white Americans, and demanded that they inform on each other when an extra pound of butter appeared. Hordes of Jews and their Mafia allies counterfeited millions of rationing stamps, and ploughed their profits into urban real estate.



Successful in their boycott and war against Germany, the Jews confidently proceeded with their plans to exterminate the entire German people. In 1941, Theodore Kaufman wrote in *Germany Must Perish*: "To achieve the purpose of German extinction it would be necessary to only sterilize some 48 million." Henry

Morgenthau whose father had made millions of dollars by turning the pleasant New York area of Harlem into a vast black slum, persuaded Roosevelt to adopt his Morgenthau Plan for exterminating the Germans. His assistant, the Lithuanian Jew and Soviet agent Harry Dexter White, succeeded in dismantling hundreds of Germany's factories and shipping them to Russia, where they rusted for years

on railroad sidings, because the Russians did not know how to reassemble them. During this time, the Germans built new factories which forced the economies of the Jewish allies, England and France, towards bankruptcy.

The British writer, George Orwell, horrified by the total control which Jewish society exercised over every aspect of members of the Jewish community, wrote a book warning that this Jewish society might someday extend its dictatorship over all peoples. He called his book "1984", and it became a best seller, but to this day no one has ever revealed that it is a case history study of Jewish dictatorship.

Many naive gentiles supported the establishment of the State of Israel, which was founded on the horrors of such terrorist acts as the bombing of the King David Hotel and the murder of the United Nations observer, Count Folke Bernadotte, because they supposed that all of the Jews would emigrate there to live. They knew nothing of the phenomenon of biological parasitism, or that Jews had no intention of voluntarily giving up their encysted positions in Western civilization. Anti-Jewish sentiment has always been a hallmark of Western culture, and has usually been found only in the most advanced centers of our society, such as Vienna, where Hitler first studied the Jewish problem, and in London and Paris. The greatest thinkers, such as Lothrop Stoddard and Houston Stewart Chamberlain, warned us of the Jewish peril, while the Jews hired the most craven and diseased politicians in the Western nations, such as Roosevelt and Churchill, to advance their cause.

During World War II, the brilliant Virginian, Lady Astor, was present at a wartime meeting of Churchill and Roosevelt and remarked to her companion, "Just look at those two great humanitarians! Franklin hates anyone who can walk, and Winston hates anyone who is sober."



While the Jewish-dominated powers

have lamely defended Israel's continued acts of aggression and genocide against the Arab people, other nations have demanded that she be brought to account. In response, the Jews intensified their worldwide propaganda campaign to defend their atrocities. They brought off a master stroke when they placed a Jew in New York as head of all Arab propaganda activities in the United States. Of course the American people remained uninformed about the Arab cause after this new treachery. Nevertheless, worldwide feeling against the Jews continued to mount. A new master stroke of propaganda was needed. The Jews achieved this by their ancient technique of claiming that their opponents were guilty of the very atrocities that the Jews were committing. Founded on terrorism, the State of Israel now became the secret organizer of an "anti-Israel" group, the Palestine Liberation Organization. One Yasser Arafat, whose mother was Jewish, became the head of the greatest Jewish hoax in history. Nevertheless, the PLO was responsible for the survival of Israel, as each attack by the PLO has resulted in renewed worldwide sympathy and support for Israel. Each PLO attack has come just at the moment when the demands that Israel return to its 1948 borders have reached a crescendo, and after the attack the demands against Israel have been hushed. Thousands of young Arabs were persuaded to join the PLO under the delusion that they would strike at the enemy. Instead, they were sent out to be slaughtered. For years, Jewish insiders have joked about the nightly "turkey shoots", as Israelis leisurely shot down the PLO infiltrators, whose exact route, number and armaments had been radioed to the Jews even before the "terrorists" had left their base. The "turkey shoots" became a popular Israeli sport, and high-ranking officials such as Moshe Dayan took part in picking off the "terrorists". On one occasion, a very high-ranking State Department official was allowed to pick off his "turkey", a seventeen-year-old Arab youth.

On necessary occasions, to stifle foreign critics, the Jews allowed a few of the infiltrators to proceed to some small Israeli village where they shot a few Jews before being killed. The Jews also ordered the murder of two State Department officials in the Sudan, to excite Americans against the Arabs. The greatest propaganda stroke of the Jewish-directed PLO was the "massacre" of Israeli athletes at the Olympic Games in Munich. Yasser Arafat was invited to speak to the United Nations, where he stood brandishing a gun. He was repeatedly

interviewed on the Jewish program, Sixty Minutes, where his interviewer, Mike Wallace, showed no discomfort at being in the presence of "the most dangerous Jew-killer in the world". Col. Eugene Sanctuary told me in 1952, "To find out who the Jews have in their pocket, merely observe to which of their 'enemies' they give the most publicity. Their true enemies always get the silent treatment."

Meanwhile, the Arab leaders were kept busy denying any connection with the PLO, making them seem even more disunited than before. It was obvious to experienced political observers that the PLO was being directed by the Jews. None of its activities were of the slightest benefit to the Arabs, but every act of its "terrorists" reaped a vast new harvest of support for Israel. The "outrages" committed by the PLO were particularly useful to the craven politicians in the United States, because it gave the cover of "humanitarianism" to their acts of high treason in support of Israel and against the interests of the American people.

The next great hoax of the Jews was the creation of OPEC, the cartel of oil producing nations. OPEC was not an Arab creation at all, but the brainchild of two Jews from Venezuela, who conceived the idea of persuading the Arabs to triple the price of their oil. The Arabs were skeptical of Jews bearing gifts, and they had no real need of increased revenues. However, the Arab world was one of startling paradoxes, as the Arab nations which had outlawed the Communist Party were being supplied with arms by the Soviet Union. The Arabs finally agreed, and the Western democracies were thrown into economic chaos, while fifty billion dollars of their capital funds flowed into Arab banks. It should surprise no one that most of this money wound up in Jewish hands. There was one important exception, the Arab banks in Beirut, Lebanon. It was imperative to the well-being of the Jewish financial empire that these Arab banks be destroyed. Southern Lebanon was the site of many Palestinian refugee camps and the staging area for PLO "raids" into Israel.

After each of these abortive raids, Israeli planes attacked the refugee camps and killed many women and children. The world remained silent in the face of these atrocities. King Hussein of Jordan, who was married to a British secret service agent, had already mounted a terrible attack against the refugees. On Feb. 18, 1977, Bob Woodward, of Watergate fame, revealed in the Washington Post

that since 1957 the CIA had privately paid King Hussein one million dollars a year for his private life of sports cars and planes, while furnishing him with blond prostitutes from London and New York.

This was in addition to the \$200,000,000 a year which the United States gave Jordan in "aid". In return, Hussein acted as an agent of the Jews, furnishing intelligence information against the other Arab leaders.

This twenty-year-old story was considered "a great scoop"!

King Faisal who opposed further OPEC increases, was assassinated. Suddenly a violent civil war broke out in Lebanon, between the dominant Christian "right-wing" party, which was controlled by the CIA and the Jews, and the Moslems, who were considered left-wing. The PLO apparently was in the middle, being attacked by both sides.

Their refugee camps were wiped out, with terrible atrocities being committed against the hapless inhabitants. The Arab banks in Beirut were blown up and burned. During the many months of this "civil war", none of the hundreds of correspondents in the area could offer an explanation of what the fighting was about, who was financing it, what the goals were, or any other details. Meanwhile, the State of Israel basked in peace and security as the Arabs massacred each other. In the United States, the Congressional investigation of the CIA came to a screeching halt when it was on the verge of exposing the CIA's setting up of the "civil war" in Lebanon.

The Jews continued their boycotts in the United States, while howling about a non-existent "Arab boycott" of U.S. firms which supported Israel. Since all U.S. firms contributed to Israel, both directly and indirectly, such a boycott could not exist. When Mexico supported a U.N. resolution that "Zionism is Racism", the Jews launched a boycott of Mexican hotels which was later called off when they realized that most of the hotels and restaurants affected were owned by Jews.

As an astute student of the Roosevelt road to power, Jimmy Carter knew that from 1933 to 1941, all of

Roosevelt's social programs were disastrous farces. Since he planned to remain in power for four terms, repealing the limitation on Presidential service, he had drawn up war plans which he believed would take him down Roosevelt's successful power play in 1941 and into a foreign war. However, Carter did not have eight years to fumble with social programs, as he was elected only by Ford's moronic decision to debate him and by Jack Anderson's smear of Howard Baker's wife as an alcoholic, panicking the neanderthal Ford into choosing Dole and losing the Southern states Baker would have brought him. Carter's advisers told him that we would have twenty percent inflation and a war plan should be instituted by that date. [*Date reference unclear – ed.*] The Chiefs of Staff gave him two areas where Russia would allow him to go without precipitating World War III - South Africa and the Middle East. His black adviser Andrew Young insisted that we go into Southern Africa and destroy the white governments of Rhodesia and South Africa, but his Jewish advisers prevailed with their final solution to the Arab problem. The American Army would impose a Pax Judaica on the Middle East, controlling or deposing as many Arab governments as possible and taking over their oil fields as they now have done in Iraq, a move which has been very popular with the American public. Russia has been given a great deal of influence in Iran. as the price of keeping hands off as will likely happen and the United States will gain control over Afghanistan and Pakistan at a later date. They will cause as much strife in Iran as they can to keep that country from playing a major role in their plans.

Having wiped out the last vestiges of opposition in the Middle East, the Jews can then turn to their final task, eliminating their last opponents, the recalcitrant white minority in the United States. A successful campaign to swamp them with non-whites has resulted in more than thirty 30 million Mexicans and other non-whites being imported into the United States. The Jew is trying to destroy the moral fiber of the remaining whites through drugs, pornography, and public lotteries. These vices have no effect on the non-whites as they comprise their normal way of life.

Many years of struggle lay ahead! The bones of our dead are crying out for, REVENGE!

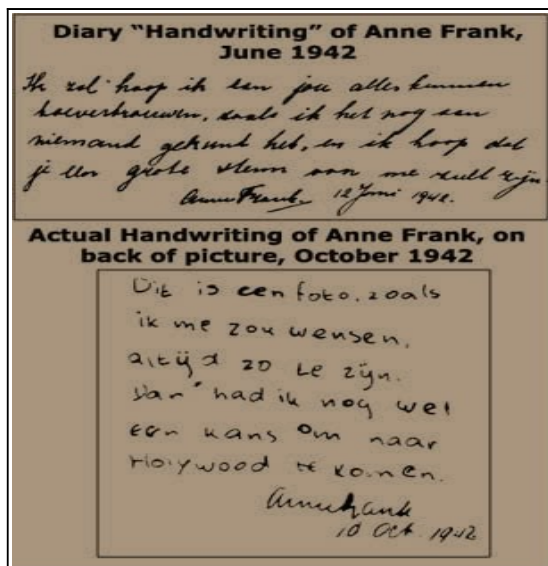

The *Diary of Anne Frank* purports to tell us about a holocaust era victim of Nazi oppression. By extension we are told to have pathos and compassion for all Jews. But the Jews feeding you this pap are disarming you by using your compassion as a weapon to bind you mind. The Jews never tell you the whole story is a fraud—no, no, no—they just shout, “Never again!” and demand you feel sorry for them, these eternal victims. America – A Warning you had better Read

Unbelievably stupid White Liberals do everything they can to outdo one other in the sensitivity for Negroes department, often even forgiving and supporting Blacks after they've been victims to their horrific violence. This appears to be some kind of Stockholm Syndrome or typical Jew-inspired White lunacy, just as they've done to White Americans over the last 50 years.

We lost our country through skilful propaganda, pressure from abroad (not least from the U.S.A.), unrelenting charges of “oppression” and “racism,” and the shrewd assessment by African tyrants that the white man has many Achilles’ heels, the most significant of which are his compassion, his belief in the “equality of man,” and his “love your neighbor” philosophy – none of which are part of the Third World’s history.

The mainline churches played a big role in the demise of Western influence throughout Africa, too; especially in South Africa. Today’s tyrants were yesterday’s mission-school protégées. Many dictators in Africa were men of the cloth. They knew their clerical collars would deflect criticism and obfuscate their real aims, which had nothing whatever to do with the “brotherhood of man.”

Other tyrants, like the infamous Idi Amin, were trained and schooled by the whites themselves, at Oxford, Cambridge, and Harvard. After receiving the best from the West, they unleashed a resentful blood-lust against their benefactors.

From what I have seen and read thus far, I fear Americans will capitulate just as we did. Americans are, generally, a soft lot. They don’t want to quarrel or obstruct the claims of those who believe they were wronged. They like peace and quiet, and they want to compromise and be nice.

A television program that aired in South Africa showed a town meeting somewhere in Southern California where people met to complain about falling standards in the schools. Whites who politely spoke at the meeting clearly resented the influx of Mexican immigrants into their community. When a handful of Chicanos at the back of the hall shouted and waved their hands at them, the whites simply shrunk back into their seats rather than tell the noise-makers to shut up. **They didn’t want to quarrel.**

In America, the courts are still the final arbiters of society’s laws. But what will happen when your future majority refuses to abide by court rulings — as in Zimbabwe. What will happen when the new majority says the judges are racists, and that they refuse to acknowledge “white man’s justice”? What will happen when the courts are filled with their people, or their sympathizers? In California, Proposition 187 has already been overturned.

What will you do when the future non-white majority decides to change the names of streets and

cities? What will you do when they no longer want to use money that carries the portraits of old, dead white “racists” and slave owners? Will you cave in, like you did on flying the Confederate flag? What about the national anthem? Your official language? Don’t laugh. When the “majority” took over in South Africa, **the first targets were our national symbols.**

In another generation, America may well face what Africa is now experiencing — invasions of private land by the “have-nots;” the decline in health care quality; roads and buildings in disrepair; the banishment of your history from the education of the young; the revolutionization of your justice system.

In South Africa today, only 9 percent of murderers end up in jail. Court dockets are regularly purchased and simply disappear. Magistrates can be bribed as can the prison authorities, making escapes commonplace. Vehicle and air-plane licenses are regularly purchased, and forged school and university certificates are routine.

What would you think of the ritual slaughter of animals in your neighbor’s backyard? How do you clean up the blood and entrails that litter your suburban streets? When Robert Mugabe of Zimbabwe murders his political opponents, ignores unfavorable court decisions, terrorizes the population and siphons off millions from the state treasury for himself and his friends, South Africa's new President Thabo Mbeki holds his hand and declares his support. That just happened a few weeks ago.

Your tax dollars will go to those who don't earn and don't pay. In South Africa, organizations that used to have access to state funds such as old age homes, the arts, and veterans' services, are simply abandoned.

What will happen is that Western structures in America will be either destroyed from without, or transformed from within, used to suit the goals of the new rulers. And they will reign either through terror, as in Zimbabwe today, or exert other corrupt pressures to obtain, or buy votes. Once power is in the hands of aliens, don't expect loyalty or devotion to principle from those whose jobs are at stake. Warrior of Flight and Freedom

We are constantly hearing about how progressive America is in respect to the advancement of women. However in National Socialist Germany, capable women naturally rose to positions that they were qualified for - rather than being forcibly shoe-horned into positions simply because they were women. Editor

Germany's celebrated woman test pilot who had flown the V1 rocket bomb in sub orbital flight in the early 1940's, 20 years before the first American spaceman, was actually history's first astronaut. She held 40 world aviation records, was the first to cross the Alps in a glider, first to fly a helicopter and first to fly a jet plane. She was the first woman awarded the iron Cross and was the world's first woman test pilot.

Hanna Reitsch is unusual in being a feminine woman who was yet the equal of men in a dangerous male profession – test-piloting new military aircraft. Her love of flying from childhood on, along with her superior intelligence, determination, and ability to withstand tremendous stresses, gave her the edge that allowed her to rise to the top of the aviation world.

Hanna Reitsch offered her gifts to the German nation in the same way that Adolf Hitler and many others did – with a complete giving of herself and her abilities, holding nothing back. Although she lived to 1979, she never renounced her participation with the National Socialist government or criticized Hitler, even under pressure to do so. Hanna's life story is an amazing one that sounds almost unbelievable in its drama and acts of heroism. She never married or had children; instead she occupied herself with the two burning loves of her life – flying and the salvation of her beloved Fatherland in its time of need.

Reitsch was born on March 29, 1912, in Hirschberg, Silesia. Always fascinated with flying, she reportedly attempted, at age four, to jump off the balcony of her home. In her 1955 autobiography *The Sky My Kingdom*, she wrote: "The longing grew in me, grew with every bird I saw go flying across the azure summer sky, with every cloud that



sailed past me on the wind, till it turned to a deep, insistent homesickness, a yearning that went with me everywhere and could never be stilled."

At age 14, to assuage both her Protestant ophthalmologist father and her devout Catholic mother, she decided to become a flying missionary doctor in Africa. She came to an agreement with her father that she would be allowed to learn how to fly after she completed secondary school IF she did not mention it to him again during that time. Thanks to her

determined silence, she managed to fulfill that pact and was allowed to go to the Grunau School of Gliding, with the condition that she also take a course in "domestic science."

Reitsch undertook these studies at the Colonial School for Women at Rendsburg. The course included how to care for domestic animals as well as to ride and shoot. While she could appreciate the value of what she was learning, her real goal remained flying. She was the only woman in gliding school, and was derided by both the male students and instructors. Authorities were so taken aback when she was the first class member to pass the "A" level beginning course that they made her retake the test -- which she once again passed. She went on to pass the "B" and "C" tests before beginning medical school at the University of Berlin.

Again she sought permission from her parents to continue with flying lessons. She later recalled, "I managed to convince them that for my career as a flying doctor in Africa it would be necessary for me to learn to pilot engined aircraft." Deciding that a pilot needed to understand how the engines of their planes worked just as a doctor needed to know about the heart, she started to hang out with the mechanics at the flight school. As they saw she was not averse to hard work or dirty hands, and was serious about learning about air-plane engines, she worked herself in their favor.

The quality of Reitsch's determination is revealed in the following incident:

One Friday the master mechanic pointed to a worn-out engine and told her that she could have it to take apart and put back together again by the following Monday. She did just that, later recalling, "on the Monday morning, with torn and bleeding hands and covered from head to foot in oil and grime, I was able to show the foreman the reassembled engine."

When Reitsch decided she needed to learn to drive an automobile, she solved the problem in the same creative and hard-working fashion - she did the dirty jobs for the workmen who were operating earthmoving machinery near the airstrip while asking them questions about clutches, brakes, chokes and carburetors. They finally let her drive some equipment.

The Test Pilot

In 1934 Reitsch traveled to Brazil and Argentina as part of a German research expedition to test-fly gliders in extreme thermal conditions. Because of her growing reputation as a pilot and the opportunities now presented to her, Reitsch left medical school and accepted an invitation to become an experimental glider test pilot at the *Deutschesforschungsinstitut für Segelflug* (DFS), the German Research Institute for Sailplane Flight at Darmstadt, where she was involved in flight testing to address problems of stability and control, and structural vibration. She also test-flew the first glider seaplane and evaluated the capabilities of new glider catapult mechanisms.

In 1936 Reitsch met Ernst Udet, the highest-scoring German fighter ace to survive World War I, then a head man at the Ministry of Aviation. At the time,

she was working on the development of dive brakes for gliders. After demonstrating the use of dive brakes in a vertical dive before Udet, other *Luftwaffe* generals and German aircraft designers, she was awarded the honorary rank of *Flugkapitän*, the first woman ever so honored. In 1937 she was designated as a *Luftwaffe* civilian test pilot, a post she would hold until the end of World War II. Reitsch and Udet shared a passion for flying and developed a close professional relationship that lasted until Udet's death in November 1941.

Another former fighter pilot who was impressed watching Reitsch's high-speed dive brake tests was Robert Ritter von Greim, a Bavarian ace who had scored 25 WWI aerial victories, been awarded a knighthood and the coveted Orden Pour le Mérite. Greim was the first squadron leader of the new *Luftwaffe*, appointed by Reichsmarschall Göring.

In the years leading up to WWII, Reitsch made a name for herself by being one of the first Germans to fly a glider over the Alps, setting a world long-distance record in gliding, and winning the National Soaring Contest - the only woman entrant. She also traveled extensively, to Africa and to the United States. After completing her test pilot duties in the development of dive brakes, Udet appointed her a civilian test pilot at the primary *Luftwaffe* research station at Rechlin, where she was allowed to fly most of the high-performance aircraft in the *Luftwaffe* inventory. She viewed them as guarantors of peace, later writing: "Stukas - bombers - fighters! Guardians at the portals of Peace! And in this spirit I flew them, each time in the feeling that, through my own caution and thoroughness, the lives of those who flew after me would be protected and that, by their existence alone, they would contribute to the protection of the land that I saw beneath me as I flew.... Was that not worth flying for?"

In February 1938, Reitsch would become the first person to fly a helicopter inside a building, Berlin's *Deutschlandhalle*. She had previously been called on to demonstrate the Fa-61 to American aviation legend Charles Lindbergh at Bremen, whom she afterward

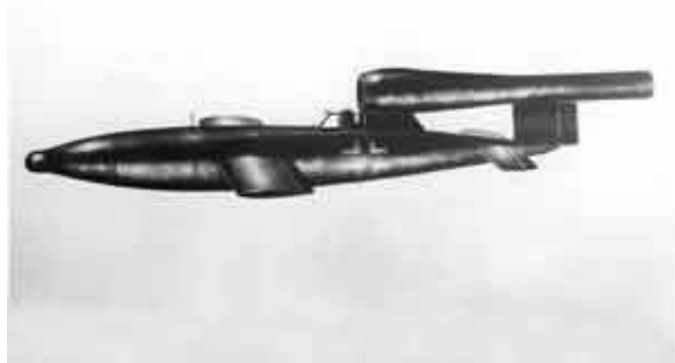


described as a man "whose simplicity of manner won all hearts wherever he went." She also became the first woman to be awarded the Military Flying Medal, thanks to her helicopter flights. Reitsch successfully completed the series of indoor demonstrations to prove that the helicopter was fully controllable. But as she later wrote, "Exactly how deep an impression my flight with the helicopter had made on the world at large I was not to realize till many years later, in 1945, [when] I came across an American soldiers' magazine....The first thing that caught my eye was my name and then I saw that it contained an article describing in popular terms my flight with the helicopter."

Reitsch visited the United States in August 1938 to make an appearance at the International Air Races at Cincinnati. She enjoyed the trip, even though she did encounter some anti-German sentiment. Her demonstration of Hans Jacobs' aerobatic glider, the Habicht (goshawk), was received with great applause by the Americans.

War Years

In 1939 she suffered through a three-month bout with scarlet fever, followed by muscular rheumatism. But she recovered and went right back to work, later undertaking a very dangerous assignment involving the development of barrage balloon cable shears for German bombers. By 1942, she was test-flying the bullet-shaped Messerschmitt ME 163 Komet, driven by a liquid hydrogen Walther rocket engine. But there were a few problems. Standing at only five foot one, the cockpit was not built for someone her size. It was hard for her to reach the rudder pedals, plus she could not use the shoulder harness because of needing to lean forward to operate the controls.



In her fifth flight in the Komet, everything was fine until Reitsch went to drop the takeoff undercarriage and it failed to fall away. The plane began to

shudder and despite her and the tow-plane pilot's best efforts of maneuvering, the undercarriage would not dislodge. To Reitsch it was unthinkable to abandon such an expensive aircraft, so she decided to try to land it without knowing how the landing gear had configured itself. She brought it down into a plowed field near the runway, but the plane flipped over, catapulting Reitsch's face into the instrument panel. She tried to get out but couldn't, so - feeling she might not survive to give her report - she spent the time sketching and labeling the details of the accident. Moving the clipboard because blood was splashing onto it from her face, she noticed a rubbery object in her lap and picked it up. It was her nose.

Reitsch's injuries were extensive. She'd fractured her skull in six places, smashed the bones of her detached nose irretrievably, displaced her upper jawbone, broken several vertebrae and bruised her brain severely. She nearly died.



Four days later, Reitsch was awarded a special diamond-encrusted version of the Gold Medal for Military Flying by *Reichsmarschall* Göring. But it took five months of plastic surgery and neurosurgery to repair her face, and five more months for Reitsch to recover from physical weakness and normal mental depression. She put herself on a regimen of tree and roof climbing to restore her sense of balance. When Adolf Hitler himself awarded Hanna Reitsch the Iron Cross of the Knight's Cross, First Class, the only woman ever to receive this medal, he forbade her to ever again attempt such a foolhardy feat.

Before she had doctor's permission, Reitsch began to fly again, starting with gliders and moving on to powered aircraft and strenuous aerobatic maneuvers, until she was satisfied her skills were as

good as ever. She learned the details of the pulse-jet powered V-1 buzz bomb and the V-2 ballistic missile programs run by General Walter Dornberger and Wernher von Braun. She was present but unhurt in the first Allied bombing raid on the Peenemünde-West complex, which left it a pile of rubble.

Operation Self-Sacrifice

Shortly thereafter, she met with a group of friends in Berlin who discussed what they could do to save Germany from a slide into defeat. The group came up with aerial strikes on Allied targets carried out by suicide bomber pilots, and called their concept, Operation Self-Sacrifice.

When Reitsch discovered she was no longer allowed to fly the ME 163, which was currently in production, she accepted a request from her long-time friend Ritter von Greim to visit him on the Russian front to boost the morale of the troops. Seeing the conditions there, the bloody realities of the war were driven home to her, and she determined to press the idea of the special corps of suicide pilots. Early in 1944 she was able to bring up the subject of Operation Self-Sacrifice with Hitler himself when she was in *Berchtesgaden* to receive her Iron Cross. Hitler dismissed the idea, believing it would not be an effective use of Germany's limited resources, and diverted the conversation, but we know how persuasive Reitsch can be. He eventually gave permission for experimental work only.

Reitsch formed an alliance with SS-Hauptsturmführer Otto Skorzeny, a noted commando, and another test pilot, Hauptmann Heinrich Lange, and the three sought to form a unit of *Selbstopfermänner* (self-sacrifice men) who would offer their lives if necessary to accomplish their mission. Adolf Hitler had insisted that the pilots be given some means of escape, and the Germans went to great lengths to distinguish their *Selbstopfermänner* from the Japanese Kamikaze pilots, whose cockpits were sealed close before take-off.

The project was given the code-name *Reichenberg* and within 14 days, three training models and the operational model had been designed and put under test. The Fi 103R was to be carried by a parent aircraft and released near the target. The pilot would then take over and guide the bomb to a dive toward the target, and he was to detach the canopy and bale

out just before impact. The canopy, however, would very likely block the pulsejet inlet and reduce the chance of pilot survival to almost zero.

The planners hoped to use the V-1 guided glider bomb then entering operational status. In the course of test flights, Reitsch identified some problems and contributed to improving the accuracy of the V-1. It's interesting that the official reports say Hanna Reitsch had the special physical ability to withstand tremendous pressures and thus was well suited to solve the special problem with the V-1 rocket. She was the only person to successfully fly it. She was designated an instructor of volunteer pilots in the Leonidas Squadron; this was dangerous work and there were deaths and injuries. Reitsch encountered numerous difficulties with the project and it never took off even though some 70 pilots volunteered for training, largely because of the prevailing attitude among high-ranking Nazis, including Goring, that the very idea of suicide-pilots was "un-German" and went against the grain of the German psyche.

It wasn't until April 1945, with the Luftwaffe under pressure from every side, that Göring made the decision to authorize suicide missions. Volunteer pilots would ram the remaining ME



109's into Allied bombers. The first mission was code named "Werewolf" and the Führer gave the go ahead. Several hundred volunteers were given ten days of ideological training at Stendal. On April 7, "Werewolf" was executed -183 fighters, the bulk of them Me Bf 109G, challenged some 1,300 American bombers, accompanied by about 850 fighters. Seventy pilots died; only 15 planes survived, with only a few succeeding in smashing into the enemy bombers before being shot down. On April 16, as the Soviets pushed across the Oder River, sixty more suicide pilots crash-bombed their planes into the Oder bridges in a desperate attempt to save Berlin.

In the Bunker

The last months of Reitsch's wartime service involved flying wounded soldiers into hospital airstrips, carrying urgent dispatches by air and surveying air routes into the rubble of Berlin. Then, on April 25, 1945, Reitsch's friend Col. General von Greim, knowing of her experience and expertise flying around the capital, asked her to fly him into Berlin in a helicopter, as he had been summoned to a meeting with Hitler. Assuming they would never return from this flight, he first asked her parent's permission, which they gave. She traveled to Salzburg where they had retreated to say goodbye to them, and to others of her family. Arriving at Rechlin Air Base, she learned the situation in Berlin had worsened, plus the helicopter they had intended to use had been destroyed.

Another pilot was to fly von Greim to Gatow in a single seater Focke-Wulff 190, but Reitsch questioned how he would get from there to the Reich Chancellery. She asked if she could be crammed into the back of the plane, so that, with her knowledge of the Berlin center, she could see that von Greim found his way to the Chancellery. This was done and she describes it as the most terrifying plane ride of her life, as she was completely immobile and sightless the entire time.



Upon landing, they learned that all the approach roads into the city were in the hands of the Russians. They finally decided to try to fly into Berlin in a Fiesler Storch (stork) and land at the Brandenburg Gate. At 6 p.m. they took off in the only Fiesler Storch left, with Greim at the controls and Reitsch crouched behind him. As a hail of Soviet anti-aircraft fire hit the engine and fuel tank, an armor-piercing bullet smashed Greim's right foot, and he passed out. Reitsch, using only hand controls, managed to successfully land the Fieseler on the boulevard before the Brandenburg Gate, and they both made it into Hitler's bunker.

Now began events even more dramatic and historic

than what Hannah Reitsch had already experienced in her event-packed life. Reitsch and Greim remained in the bunker until early morning April 30. Present, along with Hitler and Eva Braun, were the Goebbels with their six children; State Secretary Naumann; Martin Bormann; Hewel from Ribbentrop's office; Admiral Voss as representative from Dönitz; General Krebs of the infantry and his adjutant Burgdorf; Hitler's personal pilot Hans Baur, and another pilot Bätz; SS Obergruppenführer Fegelein as liaison with Himmler; Hitler's personal Physician, Dr. Stumpfegger; Oberst von Below, Hitler's Luftwaffe Adjutant; Dr. Lorenz representing Reichspresse chief Dr. Dietrich for the German press; two of Hitler's secretaries, and various SS orderlies and messengers.

Outside, SS elite troops were committed to guarding Hitler to the end. Inside, after Greim's foot was operated on by Hitler's physician, the Führer came into the room and expressed deep gratitude for his coming, saying that even a soldier had the right to disobey an order when everything indicates it would be futile and hopeless. Hitler then informed Greim of Goring's betrayal and Greim's succession to commander-in-chief of the Luftwaffe. He said to Greim, "*In the name of the German people I give you my hand.*"

Shocked, both Reitsch and Greim asked to stay with him in the bunker to the end. Hitler agreed at the time and, later that night, according to Reitsch's Allied interrogation report, gave Hannah a vial of poison for herself and Greim, as everyone else already had, saying "I do not wish that one of us falls to the Russians alive, nor do I wish our bodies to be found by them." Reitsch, sobbing, begged her Führer to save himself and not deprive the German people of his life. That, she said, is the will of every German. Hitler answered that, "as a soldier, I must obey my own command that I would defend Berlin to the last." He explained other things, and told her he still had hope that Wenk's army could arrive from the South, but this was in case it came to the worst.

Hanna returned to Greim's bedside and they decided together that should the end really come, they would quickly drink the contents of the vial and then each pull the pin from a heavy grenade and hold it tightly to their bodies.

On the 27th, Obergruppenführer Fegelein

disappeared. Shortly thereafter, he was captured on the outskirts of Berlin disguised in civilian clothes, claiming to be a refugee. Hitler ordered him shot, but this event caused some doubt as to Himmler's position. And, indeed, on the 28th, a telegram arrived which indicated that Himmler had joined the traitor list by contacting British and American authorities through Sweden to propose a capitulation. This was a personal blow to Hitler, and was followed by the news that the Russians would make a full-force attack on the Chancellery on the morning of the 30th.

Just after midnight on that day, Hitler came to Greim's room and ordered him to return to Rechlin to muster his planes to destroy the Soviet positions from which they would attack the Chancellery, and also to stop Himmler from succeeding him as Fuhrer. Greim and Reitsch both protested that they would never reach Rechlin, the attempt was futile, but after a bit Greim agreed that every effort must be made, if just to give the light of hope to those in the bunker. Hannah, though, went again to Hitler and begged that they be allowed to stay and die with him. According to her, he just looked at her for a moment and said, "God protect you."

So, preparations being quickly made, thirty minutes after Hitler gave the order, they left the bunker. They took with them two letters to Magda Goebbels' son who was then in an Allied Prisoner of War Camp and a diamond ring given to Hanna by Frau Goebbels, to wear in her memory. Greim was urged by von Below to get out so that he could "tell the truth to our people" and "save the honor of the Luftwaffe." SS men brought up a small armored vehicle which took Reitsch and Greim to where an Arado 96 was hidden, brought by the same pilot who flew them to Gatow. Reitsch said later she was certain this was the last craft available, and it was highly unlikely another could have gotten in again, even for Hitler.

Resistance and Capitulation

Now began another amazing adventure. The plane took off during a lull, the pilot circling until they reached a cloud bank that protected them, after which they emerged into a clear night sky. In 50 minutes, they reached Rechlin, then, after conferring with what remained of the Operations Staff, flew, with Reitsch as pilot in a small Buecker plane, to Ploen to confer with Doenitz. In response to Greim's order, the sky was soon filled with

German and Russian planes. Landing at Lubeek, they had to auto to Ploen, where they found Doenitz knew nothing of Himmler's actions. From there, they went to find Keitel, who on May 1st gave them the news that Wenk's army had long been destroyed or captured, and that he had sent word to that effect to Hitler the day before, on April 30. Greim and Reitsch now fully expected the suicide plans had been put into operation.

That evening, the announcement of Hitler's death was made and that Admiral Doenitz was his successor. After another short trip to Ploen, they flew in a Dornier 217 to Koeniggratz where Greim lay in hospital for four days while events moved swiftly. On May 7th news reached him that capitulation would probably take place on the 9th.

They left that night, and after crash landing in a field near Graz because of flak, took off again for Zell am See in search of Field Marshal Kesselring. By the time they got there, they learned Germany had already signed an unconditional surrender; Greim's command was at an end.

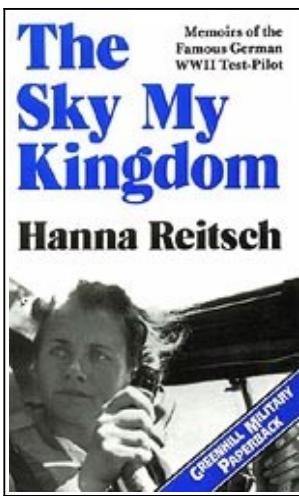
They flew to Kitzbühl on the morning of the 9th and reported to American Military authorities shortly thereafter. Greim was under treatment until the 23rd of May when he was taken to Salzburg, Austria prior to being taken on to Germany as a Prisoner of War. He

committed suicide with Hitler's poison capsule in Salzburg on the night of the 24th of May, rather than submit to the victors' torture tactics. Hanna was under extended interrogation by the Americans and then held in prison for 15 months, during which time she stubbornly refused offers to follow Wernher von Braun and others to America. While incarcerated she learned that, because of rumors that Germans from Silesia were to be returned there under the Russians, her father had killed her mother, her sister, and her sister's children, before turning the rifle on himself. Hanna, who had endured so much, endured this also.



Rebuilding her Life

With her usual determination, Reitsch tried to rebuild her life. Like all Germans under the new occupation, she was forbidden from flying until the 1950's. She lectured, wrote articles, gave newspaper interviews, and helped sick and needy people in Frankfurt while she dreamed of flying again. Still the disciplined role-model, she ran and did yoga exercises daily, and played the piano. She wore her Iron Crosses (she had received both first and second class) proudly and wrote her memoirs, *Fliegen, mein Leben* (1951), which were translated in 1954 as *Flying is My Life*. In this book she presents herself as a patriot, and makes no moral judgments about Hitler and Nazi Germany.



When allowed to fly again, Hanna returned to her true passion, gliding. Proving that she had not lost her touch, she won a bronze medal as the only female competitor at the international gliding championships in Madrid in 1952, became the German sailplane champion in 1955, flew as a research pilot, and set a women's glider altitude

record of 7,000 meters in 1957. But the following year she found herself a victim of her past when Poland refused her a visa to participate in the world glider championships there.

She established a gliding school in India, addressed the Congress in New Delhi, and took Prime Minister Jawaharlal Nehru for a sailplane ride. She also spent four years setting up a national gliding school in Ghana, where her students called her "Mother," and was received at the White House by

President John F. Kennedy. She was named pilot of the year in the United States in 1972. After a life of truly incredible adventure, honors, sacrifice, and heart-breaking losses, Hanna Reitsch died peacefully in her bed in Frankfurt, Germany, one year after setting a new women's distance record in a glider. The year was 1979; her age was 67; cause of death, heart failure.

She has described in a memoir what she calls 'my offence':

"I was a German, well known as an aviator and as one who cherished an ardent love of her country and had done her duty to the last."

Hannah Reitsch was interviewed and photographed several times in the early 1970's in Germany by US investigative photo journalist Ron Laytner. At the end of her last interview she told Laytner:

"When I was released by the Americans I read historian Trevor Roper's book, *The Last Days of Hitler*. Throughout the book like a red line, runs an eyewitness report by Hanna Reitsch about the final days in the bunker. I never said it. I never wrote it. I never signed it. It was something they invented. Hitler died with total dignity.

"And what have we now in Germany? A land of bankers and car-makers. Even our great army has gone soft. Soldiers wear beards and question orders. I am not ashamed to say I believed in National Socialism. I still wear the Iron Cross with diamonds Hitler gave me. But today in all Germany you can't find a single person who voted Adolf Hitler into power."

Then she uttered the words that for so long kept her out of the history books:

"Many Germans feel guilty about the war. But they don't explain the real guilt we share - that we lost."

Treat Cancer with IV Vitamin C

Recent clinical success

(NaturalNews) The use of IV (intravenous) vitamin C to treat cancer is growing in popularity around the world as positive research continues to accumulate and build a strong case for its effectiveness. The latest cohort study out of Germany is one more example, showing that IV vitamin C markedly improves the quality of life for breast cancer patients. Such positive results are likely the reason why many thousands of patients worldwide elect to be treated with this therapy every year.

IV Vitamin C for Cancer: Current Status

It is now well established that by injecting vitamin C we can safely reach concentrations at which ascorbate generates hydrogen peroxide (H₂O₂) in tissues, and it is the H₂O₂ that selectively kills cancer cells through oxidative stress. Laboratory studies have confirmed that high-dose vitamin C is cytotoxic to a wide variety of cancer cell lines, and that it also boosts the anti-cancer activity of several common chemotherapy drugs. In animal models (rats), IV vitamin C has been shown to significantly decrease growth rates of liver, ovarian, pancreatic, and glioblastoma tumors with dosages easily achievable in humans. The science behind IV vitamin C as a cancer therapy is now so advanced that there are six clinical trials testing it (alone or with chemo drugs) in human patients against lymphoma and cancers of the colon, breast, uterus, cervix, prostate, pancreas and others.

IV Vitamin C Helps Cancer Patients: Clinical Evidence

Clinical trials have not yet shown IV vitamin C to shrink tumours, but that's no reason for an oncologist to reject this therapy. Improving quality of life is also an important goal of cancer treatment, and clinical experience shows IV vitamin C does exactly that. A prospective study from Korea (2007) showed that this therapy significantly improved quality of life for terminal cancer patients, bringing the global health/quality of life score from 36 to 55 and yielding improvements in physical, emotional,

and cognitive functions. Disease symptom severity also decreased across the board, with patients showing significantly less fatigue, nausea/vomiting, pain, and appetite loss.

These results were echoed in a study just completed in late 2011 in Germany, which compared breast cancer patients receiving IV vitamin C and standard therapy together, versus standard therapy alone. Those receiving IV vitamin C experienced a marked reduction (nearly 50%) in unpleasant symptoms and chemo/radiotherapy side effects such as loss of appetite, fatigue, depression, sleep disorders, dizziness and haemorrhagic diathesis.

The Use of IV Vitamin C is More Widespread Than You Think

Experiences such as those above are bringing more patients to try IV vitamin C - as are high profile patients. For example, the celebrated New Zealand physicist Sir Paul Callaghan elected to treat his colon cancer with IV vitamin C, and his CEA level (a colon cancer marker) started to decrease after only six infusions. This therapy is already widespread in New Zealand: 30 clinics provide it, administering about 10,000 vitamin C injections annually. In the US, a recent survey showed that over 8800 patients were treated with IV vitamin C in 2008, using a total of 355,000 dosage vials. But that was just for the health care practitioners taking part in the survey. For the same year, manufacturers reported sales of 855,000 vials of vitamin C. This implies that as many as 21,000 patients received IV vitamin C therapy in 2008.

Ongoing clinical trials using IV vitamin C to treat cancer won't complete until 2013 to 2014. But until then, clinical evidence already shows that this therapy can - at the very least - significantly improve cancer patients' quality of life.

Oncologists should therefore strongly consider adding this therapy to their standard clinical practice.

Human Guinea Pigs?

GlaxoSmithKline's Argentina website welcomes the reader with a company disclosure that says: "We have a challenging and inspiring mission to improve the quality of human life by enabling people to do more, feel better and live longer."

Fourteen babies who participated in trials for GlaxoSmithKline's new pneumonia/earache vaccine, *Synflorix*, have DIED. However, Argentine health officials allege there was no connection to the vaccine.

According to CNN News International,

The Argentinian Federation of Health Professionals accuses drug maker GlaxoSmithKline of misleading participants and pressuring poor families into joining a trial for the Synflorix vaccine, which the company says protects against bacterial pneumonia and meningitis. ...

But GlaxoSmithKline, the world's second largest pharmaceutical company, denies those accusations and says it will appeal a judge's approval of Argentina's National Administration of Medicine, Food and Medical Technology's fining the company and two doctors a total of nearly \$240,000 for irregularities in documentation of the trial.

Bill Gates funds technology to Destroy Sperm

(NaturalNews) Mass vaccination is apparently not the only depopulation strategy being employed by the Bill & Melinda Gates Foundation, as new research funded by the organization has developed a way to deliberately destroy sperm using ultrasound technology. *BBC News* reports that the Gates Foundation awarded a grant to researchers from the University of North Carolina (UNC) to develop this new method of contraception.

The Gates Foundation awarded 78 different research projects with \$100,000 grants each as part of its "Grand Challenges in Global Health Program." Ten of these projects specifically addressed new technologies for contraception,

We intend to shop elsewhere until Tesco reverse this decision.

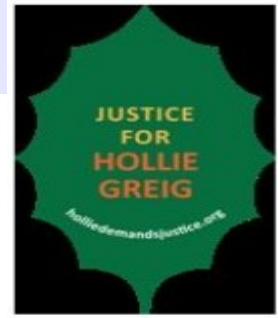

Robert Green Convicted In Court With No Jury

On Tuesday, 24th January in Stonehaven Court, Scotland, Robert Green was found guilty of Breach of the Peace, and breaking some of his bail conditions. Three other charges were dropped.

Barely reported in the mainstream press, this man has been found guilty of 'crimes' for daring to expose the facts concerning the rape and abuse of Hollie Greig at the hands of senior members of the Scottish establishment. Even before the latest 6 day hearing, the Scottish 'justice' system had spent over £500,000 trying to shut Robert up.

The UK Column said, it "is appalled by the decision of Sheriff Principle Edward Bowen to jail Robert Green today in what can only be described as a huge miscarriage of justice.

Robert has been the leading campaigner in support of justice for Hollie Greig. The legal proceedings against him came as the result of his arrest for attempting to distribute leaflets while standing as a Parliamentary candidate in Aberdeen at the last General Election. Robert had been standing on the single issue of the alleged, uninvestigated, abuse of Hollie Greig while she was a child.

Since his arrest, Robert has been subject to numerous breaches of his human rights, and repeated irregularities in the legal process, culminating in a trial presided over by a Sheriff with what seems to be a clear conflict of interest - the apparent friendship between Sheriff Bowen and Elish Angiolini. A complaint has already been lodged with the Judicial Office.

Robert has clearly been imprisoned to send a message to everyone campaigning for Hollie. While we would like to express our concerns for Robert's safety in a Scottish prison, we would also like to echo the sentiments of the Hollie Demands Justice campaign - this campaign will not be silenced through this type of blatant intimidation"

What is Christian Identity?
